III. DISCUSSION OF LEGISLATION

Representative Magee in the chair.

House Concurrent Resolution No. 6 by Representative Zeringue

Representative Zeringue presented House Concurrent Resolution No. 6, which directs flood protection districts and parish governing authorities in areas benefitting from the federal Hurricane Storm Drainage and Risk Reduction System (HSDRRS) to contribute towards the \$400 million annual payments the state must make for this project.

Representative Marcelle offered a motion to report House Concurrent Resolution No. 6 favorably. Without objection, House Concurrent Resolution No. 6 was reported favorably by a vote of 19 yeas and 0 nays. Representatives Zeringue, Adams, Bacala, Carrier, Crews, DuBuisson, Edmonds, Freeman, Harris, Jones, Kerner, Lyons, Magee, Marcelle, Miguez, Dustin Miller, Thompson, Turner, and Wheat voted yea.

House Bill No. 128 by Representative Zeringue

Representative Zeringue presented House Bill No. 128, which provides relative to the powers and duties of the Cash Management Review Board with respect to financial security and cybersecurity plans and procedures adopted by state agencies, including the assessment and deployment of such plans and procedures.

Representative Magee offered a motion to report House Bill No. 128 favorably. Without objection, House Bill No. 128 was reported favorably by a vote of 20 yeas and 0 nays.

Representative Zeringue presented House Bill No. 154, a constitutional amendment which provides relative to the maximum amount of monies in certain funds that may be invested in stocks.

Representative Francis Thompson, District 19, spoke in support of the measure, as well as the enabling legislation, House Bill No. 142.

Representative Magee offered amendments which: (1) add the Artificial Reef Development Fund and the Lifetime License Endowment Trust Fund to the list of funds for which the treasurer may invest up to 65% of fund monies in equities and (2) remove the Millennium Leverage Fund from the proposed law.

Representative Magee offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 18 yeas and 0 nays. Representatives Zeringue, Adams, Carrier, Crews, DuBuisson, Edmonds, Harris, Jones, Kerner, Lyons, Magee, Marcelle, Miguez, Dustin Miller, Romero, Thompson, Turner, and Wheat voted yea.

Representative Magee offered a motion to report House Bill No. 154 with amendments. Without objection, House Bill No. 154 was reported with amendments by a vote of 20 yeas and 0 nays. Representatives Zeringue, Adams, Bacala, Carrier, Crews, DuBuisson, Edmonds, Freeman, Harris, Jones, Kerner, Lyons, Magee, Marcelle, Miguez, Dustin Miller, Romero, Thompson, Turner, and Wheat voted yea.

House Bill No. 142 by Representative Thompson

Representative Thompson presented House Bill No. 142, which provides relative to investment authority of the treasurer.

Representative Turner offered amendments which: (1) add the Artificial Reef Development Fund and the Lifetime License Endowment Trust Fund to the list of treasury funds for which the treasurer is authorized to invest up to 65%; (2) remove the Millennium Leverage Fund from the proposed law of fund monies in equities; and (3) make technical changes. Representative Turner offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 18 yeas and 0 nays.

Representatives Zeringue, Adams, Bacala, Carrier, Crews, DuBuisson, Edmonds, Harris, Jones, Kerner, Lyons, Marcelle, Miguez, Dustin Miller, Romero, Thompson, Turner, and Wheat voted yea.

Representative Jones offered a motion to report House Bill No. 142 with amendments. Without objection, House Bill No. 142 was reported with amendments by a vote of 18 yeas and 0 nays. Representatives Bacala, Carrier, DuBuisson, Edmonds, Harris, Illg, Kerner, McFarland, Thompson, Turner, and Wheat voted yea. Representatives Adams, Freeman, and Marcelle voted nay.

House Bill No. 273 by Representative Beaullieu

Representative Beaullieu presented House Bill No. 273, a constitutional amendment which provides for changes in the expenditure limit calculation.

The administrative assistant called the roll, and House Bill No. 273 was reported favorably by a vote of 12 yeas and 4 nays. Representatives Adams, Bacala, Carrier, DuBuisson, Edmonds, Harris, Illg, Kerner, McFarland, Thompson, Turner, and Wheat voted yea. Representatives Freeman, Lyons, Marcelle, and Dustin Miller voted nay.

Representative Dustin Miller presented House Bill No. 618, which provides with respect to fiscal intermediary services contracts in state information technology procurement.

Representative Dustin Miller offered amendments which: (1) remove "enterprise architecture" from the definition of "fiscal intermediary services" used in the proposed law; (2) remove the requirement that fiscal intermediary services contracts be awarded by competitive selection; and (3) require "fiscal intermediary services" contracts to be awarded by either competitive sealed proposals, as provided in present law, or cooperative purchasing, as provided in present law. Representative Dustin Miller offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays.

Representatives Adams, Bacala, Carrier, Edmonds, Harris, Illg, Jones, Kerner, Lyons, Marcelle, McFarland, Dustin Miller, Thompson, Turner, and Wheat voted yea.

Representative Marcelle offered a motion to report House Bill No. 618 with amendments. Without objection, House Bill No. 618 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Adams, Bacala, Carrier, Edmonds, Harris, Illg, Jones, Kerner, Lyons, Marcelle, McFarland, Dustin Miller, Thompson, and Turner voted yea.

Representatives Adams, Bacala, Carrier, Deshotel, Edmonds, Illg, Jones, Kerner, Lyons, McFarland, Miguez, Dustin Miller, Thompson, Turner, and Wheat voted yea.

House Bill No. 511 by Representative McFarland

Representative McFarland presented House Bill No. 511, which provides relative to budgetary operations and funding for the Department of Transportation and Development.

Representative McFarland offered amendments which: (1) delete the requirement that the legislature appropriate funding for DOTD's operating budget from the avails of taxes from the sale, use, lease or rental, distribution, consumption, and storage for use or consumption of motor vehicles and (2) require the deposit of the avails of taxes from the sale, use, lease or rental, distribution, consumption, and storage for use or consumption of motor vehicles into the Construction Subfund of the TTF, beginning with 10% for FY 2021-2022 and increasing to 100% for FY 2030-2031 and each fiscal year thereafter.

Representative McFarland offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Adams, Bacala, Carrier, Deshotel, Edmonds, Harris, Jones, Kerner, Lyons, McFarland, Miguez, Dustin Miller, Thompson, Turner, and Wheat voted yea.

Representative Zeringue in the chair.

Representative Kerner presented House Bill No. 347, which provides relative to the Regional Maintenance and Improvement Fund.

Representatives Zeringue, Adams, Bacala, Carrier, Deshotel, DuBuisson, Edmonds, Harris, Jones, Kerner, Marcelle, Romero, Thompson, and Wheat voted yea.

House Bill No. 155 by Representative Cormier

Representative Cormier presented House Bill No. 155, which provides appropriation for the Board of Regents for Fiscal Year 2021-2022 to purchase certain chest compression devices.

Representative Zeringue offered a motion to voluntarily defer action on House Bill No. 155. Without objection, action on House Bill No. 155 was voluntarily deferred by a vote of 15 yeas and 0 nays. Representatives Zeringue, Bacala, Carrier, Deshotel, DuBuisson, Edmonds, Harris, Illg, Jones, Kerner, McFarland, Romero, Thompson, Turner, and Wheat voted yea.

For the purposes of this Paragraph, the term "source" shall mean a publication, website, person, or other source from which the data or statistical information contained in the prepared statement was obtained by the person or persons who prepared the statement.
