### III. DISCUSSION OF LEGISLATION

# **House Bill No. 21 by Representative Charles Owen**

This a continuation of the discussion on House Bill No. 21 from an earlier meeting held on April 26, 2021. Please check for the prior action to complete the records of discussion and motions on House Bill No. 21.

Representative Charles Owen presented House Bill No. 21, which provides for civil liability for the intentional dissemination of personally identifiable information.

At the request of the author, Representative Gregory Miller offered a motion to voluntarily defer action on House Bill No. 21. Without objection, action on House Bill No. 21 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Gregory Miller, Echols, Frieman, Jefferson, Jenkins, Mike Johnson, Landry, Marino, Nelson, Pressly, and Seabaugh voted yea.

## House Bill No. 255 by Representative Charles Owen

Representative Charles Owen presented House Bill No. 255, which provides relative to interdiction and curatorship.

At the request of the author, Representative Gregory Miller offered a motion to voluntarily defer action on House Bill No. 255. Without objection, action on House Bill No. 255 was voluntarily deferred by a vote of 12 yeas and 0 nays. Representatives Gregory Miller, Echols, Frieman, Jefferson, Jenkins, Mike Johnson, Landry, Larvadain, Marino, Nelson, Pressly, and Seabaugh voted yea.

Representative Jenkins offered a motion to report House Bill No. 196 favorably, to which Representative Seabaugh objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 5 yeas, 9 nays, and 1 abstention. Representatives Wilford Carter, Jefferson, Jenkins, Landry, and Larvadain voted yea. Representatives Amedee, Echols, Emerson, Frieman, Mike Johnson, Muscarello, Nelson, Pressly, and Seabaugh voted nay. Representative Gregory Miller abstained.

## **House Bill No. 59 by Representative LaCombe**

Representative LaCombe presented House Bill No. 59, a constitutional amendment which authorizes a political subdivision to waive water charges incurred through damage not caused by the customer.

Representative Gregory Miller offered an amendment to amend the ballot language. Representative Gregory Miller offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Amedee, Wilford Carter, Echols, Emerson, Frieman, Jefferson, Jenkins, Mike Johnson, Landry, Larvadain, Muscarello, and Nelson voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered a motion to adopt the House Rule 6.8(A) Report to House Bill No. 59, which stated that the measure could not be accomplished statutorily and would, therefore, require a constitutional amendment. Without objection, the House Rule 6.8(A) Report to House Bill No. 59 was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Wilford Carter, Frieman, Jefferson, Jenkins, Mike Johnson, Landry, Larvadain, Muscarello, and Nelson voted yea. Representative Gregory Miller abstained.

Representative Jenkins offered a motion to report House Bill No. 59 with amendments. Without objection, House Bill No. 59 was reported with amendments by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Wilford Carter, Frieman, Jefferson, Jenkins, Mike Johnson, Landry, Larvadain, Muscarello, and Nelson voted yea. Representative Gregory Miller abstained.

# **Senate Bill No. 9 by Senator Price**

Senator Price presented Senate Bill No. 9, which provides relative to the continuous revision of the Children's Code.

Representative Gregory Miller offered an amendment to make technical corrections. Representative Gregory Miller offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 14 yeas, 0 nays, and 1 abstention. Representatives Amedée,

Wilford Carter, Echols, Emerson, Frieman, Jefferson, Jenkins, Mike Johnson, Landry, Larvadain, Marino, Muscarello, Nelson, and Pressly voted yea. Representative Gregory Miller abstained.

Representative Jenkins offered a motion to report Senate Bill No. 9 with amendments. Without objection, Senate Bill No. 9 was reported with amendments by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Amedée, Wilford Carter, Echols, Emerson, Frieman, Jefferson, Jenkins, Mike Johnson, Larvadain, Marino, Muscarello, Nelson, and Pressly voted yea. Representative Gregory Miller abstained.

# **Senate Bill No. 91 by Senator Peacock**

Senator Peacock presented Senate Bill No. 91, which authorizes transfer on death of certain securities.

On behalf of Senator Peacock, Representative Echols offered an amendment to add a definition of "good faith". Representative Echols offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Amedée, Wilford Carter, Echols, Emerson, Frieman, Jefferson, Jenkins, Mike Johnson, Larvadain, Marino, Nelson, Pressly, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered an amendment to allow the registration of a security in beneficiary form to be cancelled or changed by any, rather than all, of the surviving owners. Representative Gregory Miller offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Wilford Carter, Echols, Emerson, Frieman, Jefferson, Larvadain, Muscarello, Nelson, Pressly, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Seabaugh offered a motion to report Senate Bill No. 91 with amendments, to which Representative Wilford Carter objected. The administrative assistant called the roll, and Senate Bill No. 91 was reported with amendments by a vote of 8 yeas, 2 nays, and 1 abstention. Representatives Echols, Emerson, Frieman, Jefferson, Muscarello, Nelson, Pressly, and Seabaugh voted yea. Representatives Wilford Carter and Larvadain voted nay. Representative Gregory Miller abstained.

## Senate Bill No. 62 by Senator Milligan

Senator Milligan presented Senate Bill No. 62, which provides relative to the management of the affairs of an interdict.

Representative Gregory Miller offered an amendment to make technical changes. Representative Gregory Miller offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Wilford Carter, Echols, Emerson, Frieman, Jefferson, Larvadain, Muscarello, Nelson, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Seabaugh offered a motion to report Senate Bill No. 62 with amendments. Without objection, Senate Bill No. 62 was reported with amendments by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Wilford Carter, Echols, Emerson, Frieman, Jefferson, Larvadain, Muscarello, Nelson, Pressly, and Seabaugh voted yea. Representative Gregory Miller abstained.

# **House Bill No. 449 by Representative Wilford Carter**

Representative Wilford Carter presented House Bill No. 449, which provides relative to the suspension of a child support obligation during the obligor's incarceration.

Representative Wilford Carter offered amendments to:

- (1) Make technical changes.
- (2) Remove the exceptions for the suspension of child support.
- (3) Modify the form of notice provided to the custodial party; remove the provision for custodial party to object to suspension; modify the procedural requirements of the Department of Children and Family Services; and provide for the contents of the order of suspension.
- (4) Change the effective date from January 1, 2022, to upon signature of the governor.

Representative Wilford Carter offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Wilford Carter, Echols, Emerson, Frieman, Jefferson, Larvadain, Nelson, Pressly, and Seabaugh voted yea. Representative Gregory Miller abstained.
