III. DISCUSSION OF LEGISLATION

House Bill No. 449 by Representative Wilford Carter

This is a continuation of the discussion on House Bill No. 449 from a meeting held on May 11, 2021. Please check for the prior action to complete the record of discussion and motions on House Bill No. 449.

Representative Wilford Carter presented House Bill No. 449, which provides relative to the suspension of a child support obligation during the obligor's incarceration.

Representative Wilford Carter offered amendments to:

- (1) Delete the amendments adopted on May 3, 2021.
- (2) Remove the provisions for the suspension and exceptions to the suspension of a support obligation during the obligor's incarceration.
- (3) Add the provisions for the reduction of a support obligation during the obligor's incarceration.
- (4) Add the conditions for which a material change in circumstances need not be shown.
- (5) Provide for the continuation of support obligations suspended pursuant to present law.
- (6) Add the provisions requiring notice and deadlines for filing certain motions.
- (7) Remove the special effective date.

Representative Wilford Carter offered a motion to adopt the proposed amendments, to which Representative Marino objected. The administrative assistant called the roll, and the amendments

were adopted by a vote of 10 yeas, 2 nays, and 1 abstention. Representatives Amedée, Wilford Carter, Frieman, Hodges, Jefferson, Jenkins, Muscarello, Nelson, Schlegel, and Seabaugh voted yea. Representatives Robby Carter and Marino voted nay. Representative Gregory Miller abstained.

Representative Wilford Carter offered a motion to report House Bill No. 449 with amendments. Without objection, House Bill No. 449 was reported with amendments by a vote of 12 yeas, 0 nays, and 1 abstention. House Bill No. 103 by Representative McCormick

Representative McCormick presented House Bill No. 103, which provides for liability relative to the administration of COVID-19 vaccinations.

Representative Frieman offered amendments to:

- (1) Delete the amendment adopted on May 3, 2021.
- (2) Make technical changes.
- (3) Replace provisions of proposed law providing for civil liability with a limitation of liability for a natural or juridical person's refusal to mandate COVID-19 vaccinations for employees and customers and add protection of business permits and professional licenses for businesses refusing to mandate COVID-19 vaccinations.

Representative Frieman offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Amedée, Robby Carter, Wilford Carter, Frieman, Hodges, Jefferson, Jenkins, Marino, Muscarello, Nelson, Schlegel, and Seabaugh voted yea. Representative Gregory Miller abstained.

Senator Mizell presented Senate Bill No. 126, which prohibits an unworthy successor from directly or indirectly benefiting from the death of his spouse or his child.

At the request of the author, Representative Gregory Miller offered an amendment to add an exception prohibiting government officials or agencies from distinguishing COVID-19 immunization requirements for students. Representative Gregory Miller offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedée, Robby Carter, Frieman, Hodges, Jefferson, Jenkins, Muscarello, Schlegel, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered an amendment to remove the venue provision. Representative Gregory Miller offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas, 0 nays, and 1 abstention. Representatives Amedée, Robby Carter, Frieman, Hodges, Jefferson, Jenkins, Muscarello, Schlegel, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller abstained.

Senate Bill No. 159 by Senator Allain

On behalf of Senator Allain, Representative Gregory Miller presented Senate Bill No. 159, a constitutional amendment which reduces the maximum rate of individual income tax and provides for a federal income tax deduction as provided by law.

Representative Gregory Miller offered an amendment to change the election date from October 9, 2021, to November 8, 2022. Representative Gregory Miller offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 14 yeas, 0 nays, and 1 abstention. Representatives Amedée, Robby Carter, Wilford Carter, Frieman, Hodges, Jefferson, Jenkins, Mike Johnson, Larvadain, Marino, Muscarello, Nelson, Schlegel, and Seabaugh voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered a motion to adopt the House Rule 6.8(A) Report to Senate Bill No. 159, which stated that the measure could not be accomplished statutorily and would, therefore, require a constitutional amendment. Without objection, the House Rule 6.8(A) Report to Senate Bill No. 159 was adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Amedée, Robby Carter, Wilford Carter, Frieman, Hodges, Jefferson, Jenkins, Larvadain, Marino, Muscarello, and Schlegel voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered a motion to report Senate Bill No. 159 with amendments. Without objection, Senate Bill No. 159 was reported with amendments by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Amedée, Robby Carter, Wilford Carter, Frieman, Hodges, Jefferson, Jenkins, Larvadain, Marino, Muscarello, and Schlegel voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered a motion to adopt the House Rules 6.8(A) Report to House Bill No. 487, which stated that the measure could not be accomplished statutorily and would, therefore, require a constitutional amendment. Without objection, the House Rule 6.8(A) Report to House Bill No. 487 was adopted by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Amedée, Robby Carter, Wilford Carter, Frieman, Hodges, Jefferson, Jenkins, Mike Johnson, Larvadain, Marino, Muscarello, Nelson, and Schlegel voted yea. Representative Gregory Miller abstained.

Representative Gregory Miller offered a motion to report House Bill No. 487 without amendments. Without objection, House Bill No. 487 was reported without amendments by a vote of 13 yeas, 0

nays, and 1 abstention. Representatives Amedée, Robby Carter, Wilford Carter, Frieman, Hodges, Jefferson, Jenkins, Mike Johnson, Larvadain, Marino, Muscarello, Nelson, and Schlegel voted yea. Representative Gregory Miller abstained.

House Bill No. 315 by Representative Goudeau

On behalf of the author, Representative Gregory Miller offered a motion to voluntarily defer action on House Bill No. 315. Without objection, action on House Bill No. 315 was voluntarily deferred by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Amedée, Robby Carter, Wilford Carter, Frieman, Hodges, Jefferson, Jenkins, Mike Johnson, Larvadain, Marino, Muscarello, Nelson, and Schlegel voted yea. Representative Gregory Miller abstained.
