Minutes of Meeting 2021 Regular Session April 22, 2021

I. CALL TO ORDER

Representative Raymond E. Garofalo, Jr., chairman of the House Committee on Education, called the meeting to order at 9:05 a.m. in Room 1, in the state capitol in Baton Rouge, Louisiana.

III. DISCUSSION OF LEGISLATION

House Bill No. 85 by Representative McKnight

Representative McKnight presented House Bill No. 85, which creates a literacy program for certain public school students.

Representative Garofalo offered amendments to House Bill No. 85 that would:

- 1. Specify that the applications the department shall process and accept are those for both students and service providers.
- 2. Specify that potential service providers shall include those with expertise in early literacy.
- 3. Change the annual deadline from October 31 to September 30 for public school governing authorities to notify parents of eligible students regarding the program application process and require that authorities notify parents after the September 30 deadline if a reading deficiency is discovered after such date.
- 4. Increase maximum payment for services per student from \$500 to \$1,000.
- 5. Specify that the teaching certificate an eligible tutor holds shall be in elementary education or reading and requires that an eligible tutor be trained in the state English language arts standards.
- 6. Add reading services provided by public schools and public school districts to the list of eligible expenses.
- 7. Change the types of funds that can be used for program purposes.

Representative Garofalo offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Garofalo, Amedee, Freeman, Jefferson, Charles Owen, Phelps, St. Blanc, Tarver, and Wright voted yea.

Without objection, House Concurrent Resolution No. 11 was reported favorably by a vote of 11 yeas and 0 nays. Representative McKnight presented House Bill No. 253, which provides relative to the governance and funding of the Special School District, which provides special education services through its schools and programs.

Representative Garofalo offered amendments to House Bill No. 253 that would increase board membership from 9 to 11 by adding a member of the Louisiana State Board of Elementary and Secondary Education (BESE) appointed by the BESE president and an additional member appointed by the governor. Representative Garofalo offered a motion to adopt the proposed amendments.

House Bill No. 409 by Representative Freeman

Representative Freeman presented House Bill No. 409, which provides relative to campus safety and accountability.

Representative Freeman offered amendments to House Bill No. 409 that would:

- 1. Revise terminology to refer to "power-based abuse" instead of "power-based violence" and revise terminology contained within the definition of "power-based abuse".
- 2. Add requirement for management boards to report annually to the Board of Regents.
- 3. Specify that each memorandum of understanding (MOU) shall be written and signed by all parties.

- 4. Revise procedures for communication between institutions about student transfers and transcript withholding between institutions relative to students under investigation.
- 5. Apply training requirement to members of the Board of Regents.
- 6. Reinstate present law relative to frequency of survey administration.

Representative Amedée offered amendments to House Bill No. 42 that would exempt private loans from proposed law. Representative Amedee offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Garofalo, Amedee, Edmonds, Jefferson, Charles Owen, Phelps, St. Blanc, Tarver, and Wright voted yea.

House Bill No. 394 by Representative Riser

Representative Riser presented House Bill No. 394, which provides for mandatory reporting of sexual misconduct at postsecondary education institutions and requires such institutions to post reports relative to campus security policies and campus crime statistics on their websites.

Representative Garofalo offered amendments to House Bill No. 394 that would remove provisions relative to mandatory reporting of incidents of sexual misconduct. Representative Garofalo offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Garofalo, Amedée, Gary Carter, Edmonds, Jefferson, Charles Owen, Phelps, St. Blanc, Tarver, and Wright voted yea.

Representative Garofalo offered amendments to House Bill No. 394 that:

- 1. Instead of providing for a Tuition Opportunity Programs for Students (TOPS) reduction for an institution's failure to comply, provides a prohibition against the Bond Commission's approving an institution's debt incurrence for a two-year period.
- 2. Limit applicability of proposed law to public institutions.

Representative Garofalo offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Garofalo, Amedée, Gary Carter, Edmonds, Freeman, Jefferson, Charles Owen, Phelps, St. Blanc, Tarver, and Wright voted yea.
