III. DISCUSSION OF LEGISLATION**Senate Bill No. 148 by Senator Cortez**

3. Add communication between institutions regarding incidents of power-based violence to the list of measures to be addressed by uniform policies of the Board. of Regents.
4. Revise procedures relative to communication between institutions and transcript withholding for transferring students.

Representative Tarver offered a motion to adjourn. Without objection, the motion passed by a vote of 11 yeas and 0 nays. Representatives Garofalo, Amedée, Brass, Freeman, Freiberg, Jefferson, Charles Owen, Phelps, Schlegel, St. Blanc, and Tarver voted yea.

The meeting was adjourned at 7:41 p.m.
