#### III. DISCUSSION OF LEGISLATION

### House Bill No. 39 by Representative Magee

Representative Magee presented House Bill No. 39, which provides relative to the recusal of judges.

Representative Gaines offered an amendment to change the term responses to reasons. Representative Gaines offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas and 0 nays. Representatives Gaines, Mike Johnson, Jones, Landry, Mack, Marino, Orgeron, Charles Owen, and Seabaugh voted yea.

Representative LaCombe presented House Bill No. 51, which changes the territorial jurisdiction of justices of the peace and constables in Pointe Coupee Parish.

Representative Hughes offered a motion to report House Bill No. 51 favorably. Without objection, House Bill No. 51 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Gaines, Edmonston, Hughes, Jones, Landry, Mack, Marino, Muscarello, Orgeron, Charles Owen, and Seabaugh voted yea.

## **House Bill No. 194 by Representative McKnight**

Representative McKnight presented House Bill No. 194, which allows a sheriff or deputy sheriff to purchase a duty weapon upon retirement for fair market value.

### House Bill No. 571 by Representative Stefanski

Representative Stefanski presented House Bill No. 571, which provides relative to alcoholic beverage delivery.

- (1) Make technical changes.
- (2) Change the distance permitted for alcohol delivery from 30 to 20 miles.
- (3) Remove proposed law changes relative to the requirement that delivery orders contain food.
- (4) Remove proposed law changes relative to a variable delivery fee.

Representative Gaines offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Gaines, Edmonston, Hughes, Jones, Jordan, Landry, Mack, Marino, Muscarello, Orgeron, Charles Owen, and Seabaugh voted yea.

Without objection, action on House Bill No. 343 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Gaines, Edmonston, Hughes, Jones, Jordan, Mack, Marino, Muscarello, Orgeron, Charles Owen, and Seabaugh voted yea.

## House Bill No. 219 by Representative Illg

Representative Illg presented House Bill No. 219, which provides relative to delivery of ready-to-drink alcoholic beverages by restaurants.

Representative Hughes offered a motion to report House Bill No. 219 favorably. Without objection, House Bill No. 219 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Gaines, Edmonston, Hughes, Jones, Jordan, Mack, Marino, Muscarello, Orgeron, Charles Owen, and Seabaugh voted yea.

### House Bill No. 263 by Representative Seabaugh

Representative Seabaugh presented House Bill No. 263, which authorizes judges of the City Court of Shreveport to serve as an attorney member of a medical review panel.

Representative Seabaugh offered a motion to report House Bill No. 263 favorably. Without objection, House Bill No. 263 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Gaines, Edmonston, Hughes, Jordan, Mack, Marino, Muscarello, Orgeron, Charles Owen, and Seabaugh voted yea.

## **House Bill No. 440 by Representative Nelson**

Representative Nelson presented House Bill No. 440, which levies fees for licenses relative to cannabis.

On behalf of Representative Nelson, Representative Mack offered amendments to:

- (1) Remove provisions establishing an annual fee for a retailer permit.
- (2) Add civil penalties of not more than \$50,000 for violations of proposed law.
- (3) Specify that proposed law is contingent on the passage of House Bill No. 699 of the 2021 Regular Session.
- (4) Add technical amendments.

Representative Mack offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Edmonston, Jones, Landry, Mack, Marino, Muscarello, Orgeron, Charles Owen, and Seabaugh voted yea.

Mike Ranatza, executive director, Louisiana Sheriffs' Association, 1175 Nicholson Dr., Baton Rouge, LA 70802, (225) 343-8402, testified in opposition to House Bill No. 440.

Representative Orgeron offered a motion to report House Bill No. 440 with amendments, to which Representative Mack objected. The administrative assistant called the roll, and House Bill No. 440 was reported with amendments by a vote of 9 yeas and 2 nays. Representatives Gaines, Jones, Jordan, Landry, Marino, Muscarello, Orgeron, Charles Owen, and Seabaugh voted yea. Representatives Edmonston and Mack voted nay.

# **House Bill No. 192 by Representative Gaines**

Representative Gaines presented House Bill No. 192, which authorizes credit card payment to manufacturers and wholesale dealers of alcoholic beverages.

Representative Jones offered a motion to report House Bill No. 192 favorably. Without objection, House Bill No. 192 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Gaines, Edmonston, Jones, Jordan, Landry, Mack, Marino, Muscarello, Orgeron, and Seabaugh voted yea.

## House Bill No. 425 by Representative Wilford Carter

Representative Wilford Carter presented House Bill No. 425, which (Constitutional Amendment) increases the number of associate supreme court justices and increases the required number of justices concurring in order to render judgment.

On behalf of the author, Representative Jordan offered amendments to:

- (1) Specify that a term of office of an existing justice may not be diminished or extended.
- (2) Require redistricting substantially equally on the basis of population shown by the census.
- (3) Require a two-thirds vote to change a supreme court district.

Representative Jordan offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Gaines, Edmonston, Hughes, Jones, Jordan, Landry, Mack, Marino, Muscarello, Orgeron, Charles Owen, and Seabaugh voted yea.

After a lengthy discussion, Representative Jones offered a motion to report House Bill No. 425 with amendments, to which Representative Seabaugh objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 6 yeas and 6 nays. Representatives Gaines, Hughes, Jones, Jordan, Landry, and Orgeron voted yea. Representatives Edmonston, Mack, Marino, Muscarello, Charles Owen, and Seabaugh voted nay.

## **House Bill No. 473 by Representative Mincey**

Representative Mincey presented House Bill No. 473, which provides relative to the age limitations to purchase vapor products.

On behalf of Representative Mincey, Representative Mack offered amendments to:

- (1) Change the term "compliance checks" to "inspections".
- (2) Delete the requirement that all compliance checks be made publicly available.
- (3) Remove the requirement for identification checks of persons who appear to be under 30 years of age and require checks for all persons.

Representative Mack offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Gaines, Edmonston, Hughes, Jones, Jordan, Landry, Mack, Marino, Muscarello, Orgeron, and Charles Owen voted yea.

Representatives Gaines, Edmonston, Jones, Jordan, Landry, Mack, Marino, Muscarello, Orgeron, and Charles Owen voted yea.

### House Bill No. 163 by Representative Brass

On behalf of the author, Representative Mack offered a motion to voluntarily defer action on House Bill No. 163, which provides relative to the creation of a retirement fund for retired sheriffs and deputy sheriffs of St. James Parish. Without objection, action on House Bill No. 163 was voluntarily deferred by a vote of 10 yeas and 0 nays. Representatives Gaines, Edmonston, Jones, Jordan, Landry, Mack, Marino, Muscarello, Orgeron, and Charles Owen voted yea.
