**III. BUSINESS**

**To review and approve the third-party convenience fee scheduled for certain online transactions pursuant to R.S. 49:316.1 for the Department of Wildlife and Fisheries**

Mr. Rob Shadoin, deputy secretary, and Mr. Alvin Henry, Jr., statewide program manager, Department of Wildlife and Fisheries, 2000 Quail Drive, Baton Rouge, LA 70808, (225) 765-2843, addressed the committee concerning the fees on certain online transactions and provided a handout, Exhibit A, which is included in the committee records.

Representative DeVillier shared that he had received complaint calls from constituents regarding paper tags used to adhere to the animals. Representative DeVillier and Mr. Henry discussed the new licensing online purchase implementation and transaction fee.

Senator Reese and Mr. Christopher Nelson, CEO, Global Processing Partners (GPP), 170 New Camellia Boulevard, Suite 100, Covington, LA 70433, (225) 316-0253, discussed the comparison of credit card fees to those of Automated Clearing House (ACH) payments.

Senator Reese and Mr. Henry discussed the department's E-tag/Text-to-Tag functionality to allow hunters the ability to text and validate their deer or turkey harvest via smartphone or website rather than by paper tags.

Representative Mincey and Mr. Nelson discussed the comparison of the Department of Wildlife and Fisheries third-party convenience fees to other Louisiana state departments.

Representative Beaulieu and Mr. Henry discussed transaction fees collected which cover technology costs submitted directly to the vendor.

Senator Smith and Mr. Henry discussed the fees associated with lifetime hunting and fishing licenses.

Senator Allain offered a motion to approve the third-party convenience fee schedules with regard to civil fines and licensing solutions by the Senate Committee on Revenue and Fiscal Affairs for the Department of Wildlife and Fisheries. Without objection, the motion to approve the third-party convenience fee schedules passed by a vote of 13 yeas and 0 nays. Senators Allain, Bouie, Lambert, Luneau, McMath, Morris, Peterson, Pope, Reese, Smith, Ward, Bernard, and Cathey voted yea.

Representative Bishop offered a motion to approve the third-party convenience fee schedules with regard to civil fines and licensing solutions by the House Committee on Ways and Means for the Department of Wildlife and Fisheries. Without objection, the motion to approve the third-party convenience fee schedules passed by a vote of 10 yeas and 0 nays. Representatives Bishop, Beaulieu, Butler, DeVillier, LaCombe, McMahan, Mincey, Orgeron, White, and Wright voted yea.

Any person who files a prepared statement which contains data or statistical information shall include in such prepared statement sufficient information to identify the source of the data or statistical information. For the purposes of this Paragraph, the term "source" shall mean a publication, website, person, or other source from which the data or statistical information contained in the prepared statement was obtained by the person or persons who prepared the statement.
