#### III. DISCUSSION OF LEGISLATION

## Senate Bill No. 53 by Senator Foil

Senator Foil presented Senate Bill No. 53, which provides certain exceptions to the crime of illegal carrying of weapons.

### Senate Bill No. 400 by Senator Fields

Without objection, action on Senate Bill No. 400 was voluntarily deferred by a vote of 11 yeas and 0 nays. ## Senate Bill No. 206 by Senator Jackson

Senator Jackson presented Senate Bill No. 206, which requires the Louisiana Public Defender Board to annually enter into a contract with the University of Louisiana Monroe to provide certain statewide training.

Representative Marcelle offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas and 0 nays. Representatives Marino, Bacala, Fontenot, Garofalo, LaFleur, Marcelle, McCormick, Muscarello, Nelson, and Seabaugh voted yea.

Representative Villio offered a motion to report Senate Bill No. 161 with amendments. Without objection, Senate Bill No. 161 was reported with amendments by a vote of 8 yeas and 0 nays. Representatives Marino, Bacala, Garofalo, Goudeau, LaFleur, McCormick, Muscarello, and Villio voted yea.

## House Bill No. 431 by Representative Jordan

Representative Jordan presented House Bill No. 431, which provides relative to DNA database cross-referencing.

On behalf of the author, Representative Marino offered an amendment to prohibit the use of DNA obtained by a criminal justice agency from the victim of a sexually-oriented criminal offense from being used for the purpose of investigating the victim of the sexually-oriented offense if that victim is charged with or suspected of committing any criminal offense. Representative Marino offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas and 0 nays. Representatives Marino, Bacala, Fontenot, Garofalo, Goudeau, LaFleur, Muscarello, Nelson, and Seabaugh voted yea.
