III. DISCUSSION OF LEGISLATION

House Bill No. 342 by Representative Hodges

Representative Hilferty announced that action on House Bill No. 342, which provides relative to discrimination by financial institutions, was voluntarily deferred.

House Bill No. 805 by Representative Green

Representative Hilferty announced that action on House Bill No. 805, which provides for insurance proceeds disbursement plans, was voluntarily deferred.

House Bill No. 950 by Representative Boyd

Representative Hilferty announced that action on House Bill No. 950, which provides relative mortgage companies, was voluntarily deferred.

House Bill No. 985 by Representative Wright

Representative Hilferty announced that action on House Bill No. 985, which provides relative to virtual currency, was voluntarily deferred.

House Bill No. 1000 by Representative Hollis

Representative Hilferty announced that action on House Bill No. 1000, which provides relative to notice requirements for excavation by communications operators or excavators, was voluntarily deferred.

Senate Bill No. 14 by Senator Pope

Senator Pope presented Senate Bill No. 14, which provides relative to the Louisiana Board for Hearing Aid Dealers.

Representative Hilferty offered a motion to report Senate Bill No. 14 favorably. Without objection, Senate Bill No. 14 was reported favorably by a vote of 10 years and 0 nays. Representatives

Duplessis, Fisher, Fontenot, Goudeau, Green, Hilferty, Hollis, LaFleur, McKnight, and St. Blanc voted yea.

Representative Goudeau presented House Bill No. 801, which provides relative to scrap metal recyclers.

Representative Hilferty offered amendments in the form of a substitute bill. Representative Hilferty offered a motion to adopt the proposed amendments. Without objection, the amendments were

adopted by a vote of 9 yeas and 0 nays. Representatives Duplessis, Fisher, Fontenot, Goudeau, Hilferty, Hollis, LaFleur, McKnight, and St. Blanc voted yea.

House Bill No. 564 by Representative Amedee

Representative Amedee presented House Bill No. 564, which creates a regulatory sandbox program within the office of financial institutions.

Representative Hilferty offered amendments to:

- (1) Create a pilot program limited to five applicants.
- (2) Add reporting requirements from the commission at the end of the program to submit to the legislature with legislative suggestions.
- (3) Add the purpose of the program.
- (4) Make technical changes.

Representative Hilferty offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Duplessis, Fisher, Hilferty, Hollis, Jordan, LaFleur, Newell, Pressly, St. Blanc, and Tarver voted yea.

Representative Hilferty offered a motion to involuntarily defer action on House Bill No. 564. Without objection, action on House Bill No. 564 was involuntarily deferred by a vote of 11 yeas and 0 nays. Representatives Duplessis, Fisher, Fontenot, Hilferty, Hollis, Jordan, LaFleur, McKnight, Newell, St. Blanc, and Tarver voted yea.

House Bill No. 802 by Representative Wright

Representative Wright presented House Bill No. 802, which provides relative to digital assets.

Representative Hilferty offered amendments to:

- (1) Remove provisions of proposed law relative to certain definitions, the provision of custodial services, written notice, cumulative application, a qualified custodian, prohibited actions, and rulemaking.
- (2) Define "bank", "custody services", "self-assessment", and "virtual currency".
- (3) Allow a bank to provide virtual currency custody services if the bank complies with certain requirements provided for in proposed law.
- (4) Allow a bank to provide virtual currency custody services in a nonfiduciary capacity and place certain requirements on a bank acting in such a capacity.
- (5) Allow a bank to provide virtual currency custody services in a fiduciary capacity and place certain requirements on a bank acting in such a capacity.
- (6) Make technical changes.

Representative Hilferty offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Duplessis, Fisher, Fontenot, Goudeau, Hilferty, Hollis, Jordan, McKnight, Newell, St. Blanc, and Tarver voted yea.

Representative Newell offered a motion to report House Bill No. 802 with amendments. Without objection, House Bill No. 802 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Duplessis, Fisher, Fontenot, Goudeau, Hilferty, Hollis, LaFleur, McKnight, Newell, St. Blanc, and Tarver voted yea.
