III. DISCUSSION OF LEGISLATION

Senate Bill No. 191 by Senator Hewitt

Senator Hewitt presented Senate Bill No. 191, which provides relative to high school core curriculum requirements.

Representative Amedée presented House Bill No. 356, which provides for the right of parents to access and examine lessons used in their child's education.

House Bill No. 369 by Representative Harris

Representative Harris presented House Bill No. 369, which requires public school governing authorities and public schools to post on their websites laws pertaining to parental access to instructional materials and the Parents' Bill of Rights.

Representative Jefferson offered amendments that required the information to be distributed to parents during the first week of school annually. Representative Jefferson offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Harris, Amedée, Freiberg, Jefferson, Charles Owen, Phelps, St. Blanc, and Tarver voted yea.

Representative Tarver offered a motion to report House Bill No. 369 with amendments. Without objection, House Bill No. 369 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Harris, Amedée, Emerson, Freeman, Freiberg, Jefferson, Charles Owen, Phelps, St. Blanc, and Tarver voted yea.

Representative Harris presented House Bill No. 453, which requires each public school governing authority to post on its website information relative to instructional materials and activities for each school under its jurisdiction.

Representative Harris offered a motion to voluntarily defer action on House Bill No. 453. Without objection, action on House Bill No. 453 was voluntarily deferred by a vote of 10 yeas and 0 nays. Representatives Harris, Amedée, Emerson, Freeman, Freiberg, Jefferson, Charles Owen, Phelps, St. Blanc, and Tarver voted yea.

House Bill No. 781 by Representative Phelps

Representative Phelps presented House Bill No. 781, which requires public high schools to provide an opportunity for certain students to register to vote. Representative Phelps showed a video of a C-SPAN broadcast of the United States House of Representatives in session entitled "Voter Registration Day".

Representative Phelps offered amendments that:

- 1. Provided for the first Tuesday after the first Monday in May to be known as Louisiana High School Seniors Voter Registration Day.
- 2. Removed a requirement that principals provide an annual opportunity for high school seniors to register to vote.

Representative Phelps offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Harris, Amedée, Emerson, Freeman, Freiberg, Jefferson, Charles Owen, Phelps, St. Blanc, and Tarver voted yea.

Representative Tarver offered a motion to report House Bill No. 781 with amendments. Without objection, House Bill No. 781 was reported with amendments by a vote of 10 yeas and 0 nays.

Representatives Harris, Amedée, Emerson, Freeman, Freiberg, Jefferson, Charles Owen, Phelps, St. Blanc, and Tarver voted yea.
