**III. DISCUSSION OF LEGISLATION**

Representative Harris offered a motion to adopt a three-minute rule for presenters, witnesses, and members to speak. Without objection, the motion passed by a vote of 9 yeas and 0 nays. Representatives Harris, Amedée, Brass, Freiberg, Jefferson, Charles Owen, Phelps, St. Blanc, and Tarver voted yea.

**House Bill No. 451 by Representative Carpenter**

Representative Carpenter presented House Bill No. 451, which requires the State Board of Elementary and Secondary Education to consider the potential fiscal impact on the local school system when reviewing a Type 2 charter school proposal.

Representative Hilferty offered amendments to delete the requirement that the State Board of Elementary and Secondary Education refer the charter proposal to the Legislative Audit Advisory Council for a recommendation as to the potential of a negative fiscal impact on the school district. Representative Hilferty offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Harris, Brass, Emerson, Freeman, Freiberg, Hilferty, Jefferson, Phelps, St. Blanc, and Tarver voted yea.

Representatives Amedée, Emerson, Freeman, Freiberg, St. Blanc, and Tarver voted nay. Representative Harris abstained.


