III. DISCUSSION OF LEGISLATION

Representative Harris offered a motion to adopt a three-minute rule for presenters, witnesses, and members to speak. Without objection, the motion passed by a vote of 8 yeas and 0 nays. Representatives Harris, Amedée, Brass, Freiberg, Jefferson, Charles Owen, St. Blanc, and Tarver voted yea.

Senate Bill No. 189 by Senator White

Senator White presented Senate Bill No. 189, which provides relative to the jurisdiction of the Central Community School System. Senator White provided various printouts relative to the Central Community School System, labeled Exhibit A in the committee records.

Representative Harris offered amendments to change the proposed geographic boundaries. Representative Harris offered a motion to adopt the proposed amendments. Representative Brass offered a motion to report Senate Bill No. 358 with amendments. Without objection, Senate Bill No. 358 was reported with amendments by a vote of 7 yeas and 0 nays. Representatives Harris, Amedée, Brass, Freiberg, Hilferty, St. Blanc, and Tarver voted yea.

Senate Bill No. 124 by Senator Abraham

Senator Abraham presented Senate Bill No. 124, which requires the state Department of Education to provide student attendance data of certain students to local school governing authorities.

Representative Amedée offered amendments to:

1. Remove the exception to the prohibition against the Department of Education recording certain children as dropouts.
2. Revise information that local school boards are not responsible for collecting.

Representative Amedée offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 7 yeas and 0 nays. Representatives Harris, Amedée, Brass, Freiberg, Hilferty, St. Blanc, and Tarver voted yea.

Representative Harris offered a motion that the House Committee on Education had determined that actions taken by the State Board of Elementary and Secondary Education in adopting state content standards for social studies were appropriate and in conformity with relevant provisions of state law, and the rules promulgating social studies standards as contained in Bulletin 1964 were acceptable. Without objection, the motion passed by a vote of 7 yeas and 0 nays. Representatives Harris, Amedée, Brass, Freiberg, Hilferty, St. Blanc, and Tarver voted yea.

V. ANNOUNCEMENTS

Chairman Harris announced that Senate Bill No. 131 by Senator Mizell, which requires public postsecondary education boards and institutions to adopt policies to acceptable use of computers and internet services, had been voluntarily deferred by the author.

VI. ADJOURNMENT

Representative Tarver offered a motion to adjourn. Without objection, the motion passed by a vote of 7 yeas and 0 nays. Representatives Harris, Amedée, Brass, Freiberg, Hilferty, St. Blanc, and Tarver voted yea.
