### III. DISCUSSION OF LEGISLATION

## **House Bill No. 960 by Representative Wilford Carter**

Representative Wilford Carter presented House Bill No. 960, which creates the North Lake Charles Economic Development District. Representative Carter provided a handout, "City of Lake Charles Resolution 101-22", Exhibit A, which is included in the committee records.

Kyle Edmiston, Visit Lake Charles, 1205 North Lakeshore Drive, Lake Charles, LA 70601, (318) 278-7431, spoke in opposition to House Bill No. 960.

Representative Edmonds offered a motion to voluntarily defer action on House Bill No. 960. Without objection, action on House Bill No. 960 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Freiberg, Gadberry, Kerner, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.

### **House Bill No. 458 by Representative St. Blanc**

Representative St. Blanc presented House Bill No. 458, which provides relative to the powers granted to the city of Franklin to regulate the storing and abandoning of junk or junked vehicles.

Representative Edmonds offered a motion to voluntarily defer action on House Bill No. 458. Without objection, action on House Bill No. 458 was voluntarily deferred by a vote of 14 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Freiberg, Gadberry, Glover, Green, Kerner, Lyons, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.

# House Bill No. 355 by Representative Charles Owen

Representative Charles Owen presented House Bill No. 355, which prohibits municipalities from enacting certain regulations relative to fuel retailers and transportation infrastructure.

Representative Stagni offered amendments to House Bill No. 355 that:

- 1. Prohibited the adoption of any directive or executive order that prohibits the siting, development, or redevelopment of a fuel retailer or related transportation infrastructure.
- 2. Removed provisions that prohibited the adoption of ordinances and other regulations that results in defacto prohibition of a fuel retailer or related transportation infrastructure.
- 3. Removed provisions that prohibited requiring a fuel retailer to install or invest in a particular kind of fueling infrastructure.
- 4. Removed provisions that authorized the adoption of ordinances and other regulations that are not inconsistent with state law regarding the siting, development, or redevelopment of a fuel retailer or related transportation infrastructure.
- 5. Added provisions that authorized parishes, municipalities, other local governmental entities, and public and private groups to further define and regulate fuel retailers and related transportation infrastructure.

Representative Stagni offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Edmonds, Farnum, Freiberg, Gadberry, Glover, Kerner, Lyons, McKnight, Schamerhorn, and Stagni voted yea.

Representative Freiberg offered a motion to report House Bill No. 355 with amendments. Without objection, House Bill No. 355 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Edmonds, Farnum, Freiberg, Gadberry, Glover, Kerner, Lyons, McKnight, Schamerhorn, and Stagni voted yea.

## Senate Bill No. 237 by Senator Fields

On behalf of Senator Fields, Representative Marcelle presented Senate Bill No. 237, which creates the Sagefield Crime Prevention District in East Baton Rouge Parish.

Representative Marcelle offered a motion to report Senate Bill No. 237 favorably. Without objection, Senate Bill No. 237 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Edmonds, DuBuisson, Freiberg, Gadberry, Glover, Kerner, Lyons, Marcelle, McKnight, Newell, Schamerhorn, and Stagni voted yea.

## House Bill No. 854 by Representative Stagni

Representative Stagni presented House Bill No. 854, which provides relative to occupational diseases for members in the classified fire service.

Representative Stagni offered amendments to House Bill No. 854 that:

- 1. Made the extended presumption period applicable only to firefighters or retired firefighters who develop cancer on or after January 1, 2023.
- 2. Provided that any claim by firefighters or retired firefighters who develop cancer prior to January 1, 2023, is also subject to applicable prescriptive periods for indemnity or medical claims.
- 3. Added a limitation on the obligation of employers regarding claims filed pursuant to present or proposed law on or after January 1, 2023.

Representative Stagni offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Freiberg, Gadberry, Glover, Kerner, Lyons, Marcelle, Newell, Schamerhorn, Stagni, and Willard voted yea.

Representative Stagni offered a motion to report House Bill No. 854 with amendments, to which Representative Schamerhorn objected. Representative Edmonds offered a substitute motion to recommit House Bill No. 854 to the Committee on Labor and Industrial Relations, to which Representative Stagni objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 6 yeas and 7 nays. Representatives Edmonds, DuBuisson, Farnum, Freiberg, Gadberry, and Schamerhorn voted yea. Representatives Glover, Green, Kerner, Lyons, Newell, Stagni, and Willard voted nay.

The original motion to report House Bill No. 854 with amendments was considered. The administrative assistant called the roll, and House Bill No. 854 was reported with amendments by a vote of 11 yeas and 2 nays. Representatives Edmonds, DuBuisson, Farnum, Gadberry, Glover, Green, Kerner, Lyons, Newell, Stagni, and Willard voted yea. Representatives Freiberg and Schamerhorn voted nay.

Witness cards submitted by those who did not speak are as follows: 5 in support, and 4 in opposition. Witness cards are included in the committee records.

### House Bill No. 1042 by Representative Hilferty

Representative Hilferty presented House Bill No. 1042, which requires certain agencies within the Department of Culture, Recreation and Tourism to evaluate certain drainage projects.

Representative Green offered amendments that limited the drainage projects to which House Bill No. 1042 is applicable to projects that divert water from municipal drainage systems. Representative Green offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Freiberg, Gadberry, Glover, Green, Kerner, Lyons, Newell, Schamerhorn, Stagni, and Willard voted yea.

Mary Kincaid, City of New Orleans, 1601 Perdido Street, New Orleans, LA 70112, (504) 941-0048, spoke in opposition to House Bill No. 1042 and presented a handout, "City of New Orleans Lakeview City Park Hazard Mitigation Project Overview", Exhibit C, which is included in the committee records.

Representative DuBuisson offered a motion to report House Bill No. 1042 with amendments, to which Representative Willard objected. The administrative assistant called the roll, and House Bill No. 1042 was reported with amendments by a vote of 8 yeas and 6 nays. Representatives Edmonds, DuBuisson, Farnum, Freiberg, Gadberry, Kerner, McKnight, and Schamerhorn voted yea. Representatives Glover, Green, Lyons, Newell, Stagni, and Willard voted nay.

Vice Chairman Stagni in the chair.

Representative Freeman presented House Bill No. 193, which provides relative to historic preservation districts and landmarks commissions in the city of New Orleans.

Representatives Edmonds, DuBuisson, Farnum, Freiberg, Gadberry, Glover, Kerner, Lyons, McKnight, Newell, Stagni, and Willard voted yea. Representative Schamerhorn voted nay.

## **House Bill No. 320 by Representative Freeman**

Representative Freeman presented House Bill No. 320, which provides relative to the violation of municipal building code ordinances and regulations in the city of New Orleans.

Representative Newell offered a motion to report House Bill No. 320 favorably. No vote was taken.

Representative McKnight offered a substitute motion to involuntarily defer action on House Bill No. 320, to which Representative Willard objected. The administrative assistant called the roll, and action on House Bill No. 320 was involuntarily deferred by a vote of 9 yeas and 5 nays. Representatives Edmonds, DuBuisson, Farnum, Freiberg, Gadberry, Kerner, McKnight, Schamerhorn, and Stagni voted yea. Representatives Glover, Green, Lyons, Newell, and Willard voted nay.

Witness cards submitted by those who did not speak are as follows: 1 in support, and 5 in opposition. Witness cards are included in the committee records.

## House Bill No. 1050 by Representative Glover

Representative Glover presented House Bill No. 1050, which provides relative to certain state property.

Representative Glover offered a motion to voluntarily defer action on House Bill No. 1050. Without objection, action on House Bill No. 1050 was voluntarily deferred by a vote of 14 yeas and 0 nays. Representatives Edmonds, DuBuisson, Farnum, Freiberg, Gadberry, Glover, Green, Kerner, Lyons, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.
