#### III. BUSINESS

# To review House Resolution No. 136 of the 2022 Regular Session relative to cost-of-living adjustments for Firefighters' Retirement System retirees

Representative Firment explained the Firefighters' Retirement System had not received a cost-of-living adjustment since 2015 although a cost-of-living adjustment could have been funded. He referred to a report, "Louisiana Firefighters' Retirement System HR 136 Committee Report and Recommendations for Cost-of-Living Adjustments for Retired Firefighters and Beneficiaries", labeled Exhibit A and included in the committee records, which studied various forms of cost-of-living benefits and different ways to fund these adjustments creatively. He noted that the authors of Exhibit A wrote on page 6: "The Committee recommends that the Legislature consider adopting a one-time lump sum nonrecurring payment for all normal service and service-connected disability retirees, including survivors, where appropriate, provided the recipient has been in pay status for five full years."
