### III. DISCUSSION OF LEGISLATION

## House Bill No. 97 by Representative Magee

Representative Magee presented House Bill No. 97, which removes the termination date applicable to levee restoration or rehabilitation work not publicly bid.

Mr. Reggie P. Dupre, Terrebonne Levee District, 220 Clendenning Road, Houma, LA 70363, (985) 868-8523, spoke in support of House Bill No. 97.

Representative Edmonston offered a motion to report House Bill No. 97 favorably. Without objection, House Bill No. 97 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Wright, Brass, Cormier, Edmonston, Glover, Horton, Larvadain, Marino, Charles Owen, Robert Owen, and Selders voted yea.

Witness cards submitted by individuals who did not speak are as follows: 18 in support. Witness cards are included in the committee records.

### **House Bill No. 855 by Representative Thomas**

Representative Thomas presented House Bill No. 855, which provides relative to medical exemptions applicable to tinting of motor vehicle windows.

Representative Edmonston offered a motion to report House Bill No. 855 favorably. Without objection, House Bill No. 855 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Wright, Brass, Cormier, Edmonston, Glover, Horton, Larvadain, Marino, Charles Owen, Robert Owen, and Selders voted yea.

### House Bill No. 319 by Representative Crews

Representative Crews presented House Bill No. 319, which adds a member with aviation experience to the Shreveport Airport Authority.

Representative Phelps spoke in opposition to House Bill No. 319.

Representative Glover offered a concept amendment to change the appointment and qualifications relative to the Shreveport Airport Authority commissioners to be applicable to each airport authority.

Representative Glover offered a motion to adopt the proposed amendment, to which Representative Horton objected. The administrative assistant called the roll, and the motion failed by a vote of 4 yeas, 11 nays, and 1 abstention. Representatives Glover, Larvadain, Pierre, and Selders voted yea. Representatives Brass, Cormier, Edmonston, Firment, Freiberg, Gadberry, Horton, Marino, Charles Owen, Robert Owen, and Schamerhorn voted nay. Representative Wright abstained.

Representative Cormier offered a motion to report House Bill No. 319 favorably, to which Representative Glover objected. The administrative assistant called the roll, and House Bill No. 319 was reported favorably by a vote of 8 yeas, 7 nays, and 1 abstention. Representatives Cormier, Edmonston, Firment, Gadberry, Horton, Charles Owen, Robert Owen, and Schamerhorn voted yea. Representatives Brass, Freiberg, Glover, Larvadain, Marino, Pierre, and Selders voted nay. Representative Wright abstained.

# House Bill No. 466 by Representative Crews

Representative Crews presented House Bill No. 466, which provides relative to the applicability of certain lease terms to airport facilities operated and managed by the Shreveport Regional Airport.

Representative Wright offered a motion to voluntarily defer action on House Bill No. 466. Without objection, action on House Bill No. 466 was voluntarily deferred by a vote of 15 yeas and 0 nays. Representatives Wright, Brass, Cormier, Edmonston, Firment, Freiberg, Gadberry, Glover, Horton, Larvadain, Charles Owen, Robert Owen, Pierre, Schamerhorn, and Selders voted yea.

# House Bill No. 630 by Representative Bryant

Representative Bryant presented House Bill No. 630, which designates a portion of Louisiana Highway 31 in Iberia Parish and St. Martin Parish as the "Judge Paul DeMahy Memorial Highway".

Representative Brass in the chair.

Representative Brass offered amendments to:

- 1. Change the highway name designation from "Judge Paul DeMahy Memorial Highway" to "Judge Paul deMahy Highway".
- 2. Add the following highway designations:
  - (a) A portion of La. Hwy. 675 from the western city limits of New Iberia to U.S. Hwy. 90 in Iberia Parish as the "Judge Charles L. Porter Highway".
  - (b) A portion of La. Hwy. 347 from La. Hwy. 96 in St. Martinville to La. Hwy. 350 in Parks located in St. Martin Parish shall be known and is hereby designated as the "Judge Carl J. Williams Memorial Parkway".
  - (c) A portion of La. Hwy. 96 in the city limits of St. Martinville in St. Martin Parish as the "Judge C. Thomas Bienvenu, Jr. Memorial Highway".
- 3. Make a technical change.

Representative Brass offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Brass, Cormier, Edmonston, Firment, Freiberg, Gadberry, Glover, Horton, Larvadain, Charles Owen, Robert Owen, Pierre, Schamerhorn, and Selders voted yea.

Representative Horton offered a motion to report House Bill No. 630 with amendments. Without objection, House Bill No. 630 was reported with amendments by a vote of 14 yeas and 0 nays. Representatives Brass, Cormier, Edmonston, Firment, Freiberg, Gadberry, Glover, Horton, Larvadain, Charles Owen, Robert Owen, Pierre, Schamerhorn, and Selders voted yea.
