# Minutes of Meeting 2024 Second Extraordinary Session February 21, 2024

#### I. CALL TO ORDER

Representative Debbie Villio, chair of the House Committee on Administration of Criminal Justice, called the meeting to order at 9:13 a.m. in Room 6, in the state capitol in Baton Rouge, Louisiana.

## III. DISCUSSION OF LEGISLATION

# House Bill No. 1 by Representative Bacala

Representative Bacala presented House Bill No. 1, which creates the Truth and Transparency in the Louisiana Criminal Justice System Program.

Representative Bacala offered amendments to:

- (1) Make technical changes;
- (2) Provide that any and all matters in criminal courts for any case filed on or after January 1, 2020, shall be transmitted to the online portal maintained by the Louisiana Clerks' Remote Access Authority;
- (3) Include the clerk of the Juvenile Court for the Parish of Orleans as an entity responsible for the transmission of juvenile court records;
- (4) Provide that all minute entries of certain juvenile records shall be transmitted to the online portal maintained by the Louisiana Clerks' Remote Access Authority rather than the Department of the Justice;
- (5) Provide that the minute entries to be transmitted to the online portal maintained by the Louisiana Clerks' Remote Access Authority shall consist of any cases filed on or after January 1, 2024, that involve any of the following:
  - (a) Any juvenile accused of committing a crime of violence; and
  - (b) Any offense committed by a juvenile where the proceeding is open to the public pursuant to present law;
- (6) Provide that certain juvenile cases and records shall remain open to the public unless sealed by a court of competent jurisdiction or until such record is expunged;
- (7) Exempt from liability the Louisiana Clerks' Remote Access Authority, including its board members, employees, and agents along with any other state, local entity, or political subdivision that is responsible for providing information to the clerks of court;
- (8) Remove proposed law relative to Department of Justice's establishment of a publicly accessible website or online portal that provides public access to the minute entries and information of certain juvenile proceedings;

- (9) Change the effective date relative to the enforceability of the duties and obligations set forth in proposed law from 120 days after proposed law becomes effective to March 1, 2024;
- (10) Relative to the obligations of the Louisiana Clerks' Remote Access Authority, or its duly authorized representative, provide that on or before August 1, 2024, a written report is to be submitted to the speaker of the House of Representatives, the president of the Senate, and the governor with the following specific information:
  - (a) Details regarding the progress made by the Authority and the clerks of court towards compliance with the duties and obligations set forth in proposed law;
  - (b) Details regarding any anticipated work to be completed to meet the duties and obligations set forth in proposed law; and
  - (c) Details regarding any anticipated dates that all remaining clerks of court are expected to be able to meet pursuant to the duties and obligations set forth in proposed law;
- (11) Require the Louisiana Clerks' Remote Access Authority, or its duly authorized representative, to submit the written report at least every one hundred twenty days thereafter until all clerks of court achieve compliance with the duties and obligations of proposed law; and
- (12) Change the effective date from May 1, 2024, to March 1, 2024.

Representative Bacala offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Villio, Bacala, Boyer, Cox, Fontenot, Horton, Mike Johnson, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Representative Knox offered an amendment to provide that the clerk of court shall comply with the provisions of Children's Code Article 412(B) when submitting the name of a juvenile who has been arrested but has not been adjudicated delinquent. Representative Knox offered a motion to adopt the proposed amendment, to which Representative Bacala objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 4 yeas and 7 nays. Representatives Knox, LaFleur, Moore, and Walters voted yea. Representatives Villio, Bacala, Boyer, Cox, Fontenot, Horton, and Wiley voted nay.

Representative LaFleur offered an amendment to remove the identity of defense counsel, if counsel is present, from the minute entries that are required to be disclosed pursuant to proposed law. Representative LaFleur offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 12 yeas and 0 nays. Representatives Villio, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Ventrella, Walters, and Wiley voted yea.

Representative Villio offered an amendment to specify that present law applies to offenses committed before August 1, 2024, rather than convictions rendered before August 1, 2024. Representative Villio offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 14 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Mike Johnson, Knox, LaFleur, Moore, Ventrella, Walters, and Wiley voted yea.

Representative Villio offered an amendment to provide that a person sentenced as a habitual offender under the Habitual Offender Law as set forth in present law shall not be eligible to receive diminution of sentence for good behavior up to a maximum amount of fifteen percent of the particular sentence imposed. Representative Villio offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 13 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Ventrella, Walters, and Wiley voted yea.

- (3) Relative to parole, clarify what is and is not a technical violation that may be addressed by an administrative sanction authorized by the committee on parole pursuant to present law.

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Mike Johnson, Knox, LaFleur, Moore, Walters, and Wiley voted yea.
