#### III. DISCUSSION OF LEGISLATION

## **House Bill No. 202 by Representative Carver**

Representative Carver presented House Bill No. 202, which creates the crime of theft of United States Postal Service mail.

David Boneno, Louisiana Bankers Association, 5555 Bankers Ave., Baton Rouge, LA 70808, spoke in support of House Bill No. 202.

Representative Adams offered a motion to report House Bill No. 202 favorably. Without objection, House Bill No. 202 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

## **House Bill No. 356 by Representative Boyd**

Representative Boyd presented House Bill No. 356, which provides for time limitations for prosecution of third degree rape.

Representative Cox offered a motion to report House Bill No. 356 favorably. Without objection, House Bill No. 356 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

### House Bill No. 97 by Representative McMakin

Representative McMakin presented House Bill No. 97, which provides relative to the crime of solicitation on certain highways and streets. Representative McMakin provided two handouts, Exhibit A and Exhibit B, which are included in the committee records.

## **House Bill No. 541 by Representative Lyons**

On behalf of Representative Lyons, Representative LaFleur presented House Bill No. 541, which amends the elements of nonconsensual disclosure of a private image.

Representative LaFleur offered an amendment to make technical changes. Representative LaFleur offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Representative Knox offered a motion to report House Bill No. 541 with amendments. Without objection, House Bill No. 541 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

### **House Bill No. 542 by Representative Cox**

Representative Cox presented House Bill No. 542, which provides for increased penalties for certain traffic-control signal violations.

Representative Cox offered amendments to:

- (1) Add a penalty of imprisonment of not more than six months when the violation results in serious bodily injury of another person; and
- (2) Add a penalty of imprisonment of not more than one year when the violation results in the death of another person.

Representative Cox offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Wanda Capdeville, Bridges Family, 404 Brookmeade Dr., Gretna, LA 70056, spoke in support of House Bill No. 542.

Representative Adams offered a motion to report House Bill No. 542 with amendments. Without objection, House Bill No. 542 was reported with amendments by a vote of 10 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, and Wiley voted yea.

## **House Bill No. 205 by Representative Glorioso**

Representative Glorioso presented House Bill No. 205, which provides for the definition of the crime of racketeering.

Representative Villio offered an amendment to change the lead author of the original bill from Representative Villio to Representative Glorioso. Representative Villio offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 12 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Representatives Villio, Bacala, Boyer, Cox, Fontenot, Horton, Knox, Ventrella, and Wiley voted yea. Representatives Adams, LaFleur, Moore, and Walters voted nay.

# House Bill No. 212 by Representative Beaullieu

Representative Beaullieu presented House Bill No. 212, which provides relative to notification procedures in certain circumstances.

On behalf of Representative Beaullieu, Representative Villio offered amendments to:

- (1) Make technical changes; and
- (2) Remove the proposed law relative to notification procedures for commutations or pardons granted by the governor.

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Ventrella, Walters, and Wiley voted yea.

- (1) Make technical changes;
- (2) Change references from "law enforcement officer" to "peace officer"; and
- (3) Replace the definition of law enforcement officer with cross-reference to definition of "peace officer".

Representative Fontenot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Ventrella, and Wiley voted yea.

Without objection, the motion passed by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.
