Minutes of Meeting 2024 Regular Session April 30, 2024

III. DISCUSSION OF LEGISLATION

Senate Bill No. 276 by Senator Pressly

Senator Pressly presented Senate Bill No. 276, which creates the crime of coerced criminal abortion by means of fraud to prohibit a third-party from knowingly using an abortion-inducing drug to cause, or attempt to cause, an abortion on an unsuspecting pregnant mother without her knowledge or consent and amends various abortion criminal laws to add the crime of attempted abortion.

Catherine Pressly Herring, no address provided, spoke in support of Senate Bill No. 276.

On behalf of the author, Representative Villio offered amendments to:

- (1) Make technical changes;
- (2) Add mifepristone and misoprostol to Schedule IV of the Uniform Controlled Dangerous Substance Law;
- (3) Provide an exception to the unlawful possession of a Schedule IV controlled dangerous substance for a pregnant woman who possesses mifepristone or misoprostol for her own consumption; and
- (4) Designate proposed law as "The Catherine and Josephine Herring Act".

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Ventrella, Walters, and Wiley voted yea.

House Bill No. 408 by Representative Mandie Landry

Representative Mandie Landry presented House Bill No. 408, which provides for the creation of the "Louisiana Voluntary Do Not Sell List".

On behalf of the author, Representative LaFleur offered an amendment to clarify that the request forms used by state police are to be in electronic format. Representative LaFleur offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 13 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Ventrella, Walters, and Wiley voted yea.

Representative Walters offered a motion to report House Bill No. 408 with amendments, to which Representative Horton objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 5 yeas and 7 nays. Representatives Adams, Knox, LaFleur, Moore, and Walters voted yea. Representatives Villio, Bacala, Boyer, Cox, Horton, Ventrella, and Wiley voted nay.

House Bill No. 627 by Representative Mandie Landry

Representative Mandie Landry presented House Bill No. 627, which provides relative to permitless concealed carry.

On behalf of the author, Representative LaFleur offered amendments to:

- (1) Specify that a person is prohibited from bringing a concealed handgun to a route of or within one hundred feet of a parade or demonstration for which a permit is issued by a governmental entity, exclusive of private property, rather than one thousand feet of a parade or demonstration; and
- (2) Provide exceptions for the following:
 - (a) A peace officer in the performance of his official duties; and
 - (b) A person with a valid concealed handgun permit issued pursuant to present law, so long as that person is within one hundred feet of the centerline of the route of a parade or demonstration.

Representative LaFleur offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, Moore, Ventrella, Walters, and Wiley voted yea.

Representative Knox offered a motion to report House Bill No. 627 with amendments, to which Representative Horton objected. The administrative assistant called the roll, and House Bill No. 627 was reported with amendments by a vote of 8 yeas and 5 nays. Representatives Adams, Boyer, Cox, Fontenot, Knox, LaFleur, Moore, and Walters voted yea. Representatives Villio, Bacala, Horton, Ventrella, and Wiley voted nay.

Senate Bill No. 17 by Senator Mizell

On behalf of Senator Mizell, Representative Villio presented Senate Bill No. 17, which adds Tianeptine to Schedule I of the Uniform Controlled Dangerous Substance Law.

Representative Villio offered a motion to report Senate Bill No. 17 favorably. Without objection, Senate Bill No. 17 was reported favorably by a vote of 12 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, Moore, Ventrella, Walters, and Wiley voted yea.

House Bill No. 630 by Representative Mandie Landry

Representative Mandie Landry presented House Bill No. 630, which provides relative to criminal prosecution of certain pregnancy outcomes.

Representative Walters offered a motion to report House Bill No. 630 favorably, to which Representative Horton objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 4 yeas and 8 nays. Representatives Knox, LaFleur, Moore, and Walters voted yea. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, and Wiley voted nay.

House Bill No. 164 by Representative Boyd

Representative Boyd presented House Bill No. 164, which provides for exceptions to the abortion laws of this state relative to rape and incest.

On behalf of the author, Representative LaFleur offered amendments to:

- (1) Make technical changes; and
- (2) Specify that "abortion" is not the termination of a pregnancy that is the result of an act that constitutes any of the following offenses when the victim is under seventeen years of age:
 - (a) Rape;
 - (b) First degree rape;
 - (c) Second degree rape;
 - (d) Third degree rape;
 - (e) Molestation of a juvenile or a person with a physical or mental disability;
 - (f) Crime against nature; and
 - (7) Aggravated crime against nature.

Representative LaFleur offered a motion to adopt the proposed amendments, to which Representative Horton objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 4 yeas and 7 nays. Representatives Knox, LaFleur, Moore, and Walters voted yea. Representatives Villio, Bacala, Boyer, Fontenot, Horton, Ventrella, and Wiley voted nay.

Representative LaFleur offered a motion to voluntarily defer action on House Bill No. 164. Without objection, action on House Bill No. 164 was voluntarily deferred by a vote of 8 yeas and 0 nays. Representatives Villio, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, and Moore voted yea.

Witness cards submitted by individuals who did not speak are as follows: 34 in support and 43 in opposition. Witness cards are included in the committee records.

Senate Bill No. 306 by Senator Cathey

Senator Cathey presented Senate Bill No. 306, which increases the penalty for human trafficking involving sexual activity of persons under the age of eighteen.

Representative Cox offered a motion to report Senate Bill No. 306 favorably. Without objection, Senate Bill No. 306 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, and Wiley voted yea.

Witness cards submitted by individuals who did not speak are as follows: 31 in support and 1 in opposition. Witness cards are included in the committee records.

Prepared statements were received via email for Senate Bill No. 306 pursuant to House Rule 14.33.

House Concurrent Resolution No. 79 by Representative Wilford Carter

Representative Villio offered a motion to voluntarily defer action on House Concurrent Resolution No. 79, which requests the Louisiana State Law Institute to study and provide recommendations relative to minimum and maximum sentencing ranges. Without objection, action on House Concurrent Resolution No. 79 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, and Wiley voted yea.

House Bill No. 56 by Representative Newell

Representative Villio offered a motion to voluntarily defer action on House Bill No. 56, which provides relative to exceptions to abortion. Without objection, action on House Bill No. 56 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, and Wiley voted yea.

House Bill No. 63 by Representative Newell

Representative Villio offered a motion to voluntarily defer action on House Bill No. 63, which amends definitions relative to the crime of abortion. Without objection, action on House Bill No. 63 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, and Wiley voted yea.

House Bill No. 293 by Representative Freeman

Representative Villio offered a motion to voluntarily defer action on House Bill No. 293, which provides for the definition of abortion. Without objection, action on House Bill No. 293 was voluntarily deferred by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, and Wiley voted yea.
