#### III. DISCUSSION OF LEGISLATION

## Senate Bill No. 401 by Senator Reese

Senator Reese presented Senate Bill No. 401, which increases the penalties for the crimes of vehicular negligent injuring and first degree vehicular negligent injuring.

Representative Villio offered an amendment to specify that the term of imprisonment shall be with or without hard labor for any person who commits the offense of first degree vehicular negligent injuring with either a blood alcohol concentration of at least 0.15 or a prior conviction for operating a vehicle while intoxicated. Representative Villio offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, and Wiley voted yea.

Zach Daniels, Louisiana District Attorneys Association, 2525 Quail Dr., Baton Rouge, LA 70808, spoke in support of Senate Bill No. 401.

Representative Horton offered a motion to report Senate Bill No. 401 with amendments. Without objection, Senate Bill No. 401 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, and Wiley voted yea.

## Senate Bill No. 467 by Senator Reese

Senator Reese presented Senate Bill No. 467, which provides for the office of the state public defender.

On behalf of the author, Representative Villio offered amendments to:

- (1) Make technical changes; and
- (2) Provide for additional court costs in certain mayor's courts with proceeds remitted to applicable indigent defender funds.

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, and Wiley voted yea.

Representative Adams offered a motion to report Senate Bill No. 467 with amendments. Without objection, Senate Bill No. 467 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, and Wiley voted yea.

# House Bill No. 130 by Representative Bayham

Representative Bayham presented House Bill No. 130, which provides relative to the crime of molestation of a juvenile.

On behalf of the author, Representative Horton offered amendments to:

- (1) Make technical changes;
- (2) Specify that the crime of molestation of a juvenile applies to a person who is in a position of supervision or entrusted with a supervisory role of the juvenile that includes but is not limited to a religious, charitable, scientific, educational, athletic, or youth-serving purpose; and
- (3) Remove provisions of proposed law relative to application of present law involving clergymen and recreational instructors.

Representative Horton offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, and Wiley voted yea.

### Senate Bill No. 421 by Senator Luneau

Senator Luneau presented Senate Bill No. 421, which creates a renaissance district in certain parishes.

On behalf of the author, Representative Villio offered amendments to:

- (1) Make technical changes; and
- (2) Authorize the majority of electors in the district, rather than the parish of Rapides, to vote in an election held for the purpose of issuance of general obligation bonds.

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Horton, Knox, LaFleur, and Wiley voted yea.

Representative LaFleur offered a motion to report Senate Bill No. 421 with amendments. Without objection, Senate Bill No. 421 was reported with amendments by a vote of 8 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Horton, Knox, LaFleur, and Wiley voted yea.

### Senate Bill No. 431 by Senator Cloud

On behalf of Senator Cloud, Representative Villio presented Senate Bill No. 431, which provides with respect to the creation of the Juvenile Detention Commission for the purpose of reviewing and recommending funding for juvenile detention centers.

Representative Horton offered a motion to report Senate Bill No. 431 favorably. Without objection, Senate Bill No. 431 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, and Wiley voted yea.

## House Bill No. 730 by Representative Mena

Representative Mena presented House Bill No. 730, which creates "The Fairness and Safety Act for Louisiana Incarcerated Workers".

On behalf of the author, Representative LaFleur offered an amendment to clarify the term "transitional work program" to include work that is done under the supervision of the sheriff of the parish where the individual is participating in such program. Representative LaFleur offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 8 yeas and 0 nays. Representatives Villio, Adams, Bacala, Cox, Fontenot, Knox, LaFleur, and Wiley voted yea.

### Senate Bill No. 413 by Senator Miller

Senator Miller presented Senate Bill No. 413, which prohibits early termination of probation and parole for certain offenses.

On behalf of the author, Representative Villio offered amendments to:

- (1) Make technical changes;
- (2) Remove provisions relative to early termination of parole; and
- (3) Relative to termination of probation or suspended sentence, move proposed law relative to vehicular negligent injuring from provisions of present law pertaining to felony cases to provisions of present law pertaining to misdemeanor cases.

Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Villio, Adams, Cox, Knox, LaFleur, Ventrella, Walters, and Wiley voted yea.

Representative Adams offered a motion to report Senate Bill No. 413 with amendments. Without objection, Senate Bill No. 413 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Knox, Ventrella, Walters, and Wiley voted yea.

Without objection, the amendment was adopted by a vote of 7 yeas and 0 nays. Representatives Villio, Bacala, Cox, Fontenot, Horton, Walters, and Wiley voted yea.
