Representative Walters offered an amendment to retain the list of offenses contained in the present constitution and add aggravated battery with a firearm to the list of offenses. Representative Walters offered a motion to adopt the proposed amendments, to which Representative Villio objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 3 yeas and 7 nays. Representatives Knox, LaFleur, and Walters voted yea. Representatives Villio, Bacala, Boyer, Cox, Fontenot, Horton, and Wiley voted nay.
