#### II. DISCUSSION OF LEGISLATION

# House Bill No. 123 by Representative Schlegel

Representative Schlegel presented House Bill No. 123, which provides for consent of a legal representative of a minor who contracts with certain parties. Representative Schlegel discussed a report from the Louisiana State Law Institute dated February 29, 2024, Exhibit A, which is included in the committee records.

Representative Wyble offered a motion to report House Bill No. 123 favorably. Without objection, House Bill No. 123 was reported favorably by a vote of 8 yeas, 0 nays, and 1 abstention. Representatives Brown, Carlson, Chenevert, Glorioso, Egan, Melerine, Turner, and Wyble voted yea. Representative Muscarello abstained.

# House Bill No. 170 by Representative Crews

Representatives Brown, Carlson, Chenevert, Edmonston, Glorioso, Egan, Mike Johnson, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

Representative Glorioso offered a motion to voluntarily defer action on House Bill No. 170. Without objection, action on House Bill No. 170 was voluntarily deferred by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Brown, Carlson, Chenevert, Edmonston, Glorioso, Egan, Mike Johnson, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

Without objection, the amendment was adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Brown, Carlson, Chenevert, Edmonston, Glorioso, Egan, Mike Johnson, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

Without objection, the amendment was adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Brown, Carlson, Chenevert, Edmonston, Glorioso, Egan, Mike Johnson, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

Representative Edmonston offered a motion to report House Bill No. 21 with amendments. Without objection, House Bill No. 21 was reported with amendments by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Brown, Carlson, Chenevert, Edmonston, Glorioso, Egan, Mike Johnson, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

# **House Bill No. 27 by Representative Melerine**

Representative Melerine presented House Bill No. 27, which authorizes service of process by commercial courier.

Representative Wyble offered a motion to report House Bill No. 27 favorably. Without objection, House Bill No. 27 was reported favorably by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Brown, Carlson, Chenevert, Edmonston, Glorioso, Egan, Mike Johnson, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.
