III. DISCUSSION OF LEGISLATION

House Bill No. 315 by Representative Mike Johnson

Representative Mike Johnson presented House Bill No. 315, which extends prescription on tort actions.

Governor Jeff Landry, P.O. Box 94004, Baton Rouge, LA 70804, spoke in support of House Bill No. 315, and provided a handout entitled "Statute of Limitations", Exhibit A, which is included in the committee records.

Representative Turner offered a motion to adopt the three minute rule for discussion, to which Representative Brown objected. The administrative assistant called the roll, and the three minute rule by a vote of 14 yeas and 1 nays. Representatives Muscarello, Carlson, Chenevert, Edmonston, Glorioso, Egan, Mike Johnson, Larvadain, Melerine, Taylor, Turner, Ventrella, Wright, and Wyble voted yea. Representative Brown voted nay.

Without objection, the amendment was adopted by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Carlson, Chenevert, Edmonston, Glorioso, Egan, Mike Johnson, Larvadain, Melerine, Taylor, Turner, Wright, and Wyble voted yea. Representative Muscarello abstained.

Representative Larvadain offered a motion to report House Bill No. 315 with amendments. Without objection, House Bill No. 315 was reported with amendments by a vote of 13 yeas, 0 nays, and 1 abstention. Representatives Brown, Carlson, Chenevert, Edmonston, Glorioso, Egan, Mike Johnson, Larvadain, Melerine, Taylor, Turner, Wright, and Wyble voted yea. Representative Muscarello abstained.

House Bill No. 423 by Representative Melerine

Representative Melerine presented House Bill No. 423, which provides for payment of recoverable medical expenses from collateral sources.

Representative Melerine offered amendments to make technical changes and to remove present law which provides that the jury is only informed of the amount billed by a medical provider and evidence of another source agreeing to pay shall not be disclosed. Representative Melerine offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Brown, Chenevert, Edmonston, Glorioso, Egan, Larvadain, Melerine, Taylor, Turner, Wright, and Wyble voted yea. Representative Muscarello abstained.

Representative Muscarello abstained.
