III. DISCUSSION OF LEGISLATION

House Bill No. 300 by Representative Orgeron

Representative Orgeron presented House Bill No. 300, a constitutional amendment, which provides relative to the disposition of funds derived from alternative energy production in the coastal area.

Representative Turner offered amendments to:

- (1) Add technical changes.
- (2) Add liens to the list of records that a Louisiana licensed attorney may use to specify the particular property subject to the bankruptcy order.
- (3) Provide that a Louisiana licensed attorney may specify by affidavit which liens, judgments, mortgages, or privileges are to be partially cancelled as to the particular property subject to the bankruptcy order.
- (4) Provide that an affidavit that specifies a particular property subject to the bankruptcy order shall include a statement that the holder of the lien, mortgage, or privilege was provided notice of the court order.

(5) Add an effective date.

Representative Turner offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas, 0 nays, and 1 abstention. Representatives Carlson, Chenevert, Edmonston, Egan, Larvadain, Melerine, Taylor, Turner, Ventrella, and Wyble voted yea. Representative Muscarello abstained.
