#### III. DISCUSSION OF LEGISLATION

## **House Bill No. 101 by Representative Farnum**

At the request of Representative Farnum, Representative Muscarello offered a motion to voluntarily defer action on House Bill No. 101, which provides relative to the Private Works Act. Without objection, action on House Bill No. 101 was voluntarily deferred by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Carlson, Chenevert, Edmonston, Egan, Glorioso, Mike Johnson, Larvadain, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

# **House Bill No. 625 by Representative Lyons**

At the request of Representative Lyons, Representative Muscarello offered a motion to voluntarily defer action on House Bill No. 625, which limits certain actions taken by governmental entities on private property owners. Without objection, action on House Bill No. 625 was voluntarily deferred by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Carlson, Chenevert, Edmonston, Egan, Glorioso, Mike Johnson, Larvadain, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

## **House Bill No. 383 by Representative Galle**

Representative Galle presented House Bill No. 383, which limits liability of operators of motor vehicles for harm caused to certain persons who are injured while illegally blocking a road or highway.

Representative Glorioso offered a motion to report House Bill No. 383 favorably. Without objection, House Bill No. 383 was reported favorably by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Carlson, Chenevert, Edmonston, Egan, Glorioso, Mike Johnson, Larvadain, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

## **House Bill No. 770 by Representative Carpenter**

Representative Muscarello offered amendments to make a technical change and to provide that when the amount for child support is not set in the schedule, under no circumstances shall the court determine an award of child support that is not in the best interest of the child or would be inequitable to the parties. Representative Muscarello offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Carlson, Chenevert, Edmonston, Egan, Glorioso, Mike Johnson, Larvadain, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

Representative Larvadain offered a motion to report House Bill No. 770 with amendments. Without objection, House Bill No. 770 was reported with amendments by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Carlson, Chenevert, Edmonston, Egan, Glorioso, Mike Johnson, Larvadain, Melerine, Taylor, Turner, and Wyble voted yea. Representative Muscarello abstained.

### Senate Bill No. 121 by Senator Coussan

On behalf of Senator Coussan, Representative Myers presented Senate Bill No. 121, which provides for the jurisdictional limits for the city courts located in the 15th judicial district.

### **House Bill No. 443 by Representative Coates**

Representative Coates presented House Bill No. 443, which provides relative to confidentiality of records in cases involving certain protected persons.

On behalf of Representative Coates, Representative Muscarello offered amendments to make technical changes and provide that if the court determines that a videotape is relevant and necessary to the case, the court may order in writing that the videotape be disclosed to the attorneys of record for each party subject to a protective order. Representative Muscarello offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas, 0 nays, and 1 abstention. Representatives Brown, Carlson, Chenevert, Edmonston, Egan, Glorioso, Mike Johnson, Larvadain, Melerine, Taylor, and Wyble voted yea. Representative Muscarello abstained.
