#### III. DISCUSSION OF LEGISLATION

# **House Bill No. 620 by Representative Riser**

Representative Riser presented House Bill No. 620, which provides with respect to geoscientist license fees.

Representative Jordan offered a motion to report House Bill No. 620 favorably. Without objection, House Bill No. 620 was reported favorably by a vote of 12 yeas, 0 nays, and 1 abstention. Representatives Carver, Cox, Domangue, Hebert, Jordan, Knox, Jacob Landry, McCormick, Mena, Newell, Riser, and St. Blanc voted yea. Representative Deshotel abstained.

## House Bill No. 679 by Representative Riser

Representative Riser presented House Bill No. 679, which provides relative to auctioneers.

Representative Deshotel offered amendments to make technical changes. Representative Deshotel offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 14 yeas and 0 nays. Representatives Deshotel, Carver, Cox, Domangue, Hebert, Jordan, Knox, Jacob Landry, McCormick, McMakin, Mena, Newell, Riser, and St. Blanc voted yea.

Representative Riser offered amendments to:

- (1) Make technical changes.
- (2) Remove definitions for soft and hard closing auctions.

- (3) Amend definition for internet-based platform.
- (4) Change exclusion in language from hard closing auction to wholesale vehicle auctions.
- (5) Change reference of incorporator to director.
- (6) Remove language on hard closing auctions.
- (7) Clarify that if an entity conducts an auction with vehicles, it does not need a valid dealer license if not required by the regulating agency.
- (8) Clarify that a copy of a dealer license is needed for conducting auctions with vehicles if license is required.
- (9) Change the deposit needed for the board from \$50,000 to \$25,000.
- (10) Reinstate repealed proposed law and amend it relative to a business owned by a nonresident auctioneer which receives its license through the reciprocity provision.
- (11) Change the amount a business owned by a nonresident auctioneer has to pay in bond from \$10,000 to \$25,000.

Representative Riser offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 16 yeas and 0 nays. Representatives Deshotel, Carver, Cox, Domangue, Green, Hebert, Jordan, Knox, Jacob Landry, McCormick, McMakin, Mena, Newell, Riser, St. Blanc, and Thomas voted yea.

Representative Riser offered a motion to report House Bill No. 679 with amendments. Without objection, House Bill No. 679 was reported with amendments by a vote of 16 yeas and 0 nays. Representatives Deshotel, Carver, Cox, Domangue, Green, Hebert, Jordan, Knox, Jacob Landry, McCormick, McMakin, Mena, Newell, Riser, St. Blanc, and Thomas voted yea.

### House Bill No. 753 by Representative Deshotel

Representative Deshotel presented House Bill No. 753, which provides relative to licensure of plumbers.

Representative Riser offered amendments to:

- (1) Change engineer board member to mechanical engineer board member.
- (2) Change board appointee from one tradesman plumber appointed by the board to one residential plumber appointment by governor.
- (3) Add two board members of the public, one nominated by the speaker of the House of Representatives and one nominated by the president of the Senate.
- (4) Change board membership to eleven and quorum to six.
- (5) Make technical changes.

Representative Riser offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 16 yeas and 0 nays. Representatives Deshotel, Carver, Cox, Domangue, Green, Hebert, Jordan, Knox, Jacob Landry, McCormick, McMakin, Mena, Newell, Riser, St. Blanc, and Thomas voted yea.

Representative Jordan offered amendments to:

- (1) Make technical changes
- (2) Allow federally insured depository institutions that are not stock-owned fiscal agency in the state.

Representative Jordan offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 17 yeas and 0 nays. Representatives Deshotel, Boyd, Carver, Cox, Domangue, Hebert, Hilferty, Jordan, Knox, Jacob Landry, McCormick, McMakin, Mena, Newell, Riser, St. Blanc, and Thomas voted yea.

Representatives Carver, Cox, Davis, Domangue, Hebert, Hilferty, Jacob Landry, McCormick, Riser, St. Blanc, and Thomas voted nay.

Representative Jordan offered a motion to voluntarily defer action on House Bill No. 239. Without objection, action on House Bill No. 239 was voluntarily deferred by a vote of 17 yeas and 0 nays. Representatives Boyd, Carver, Cox, Davis, Domangue, Green, Hebert, Hilferty, Jordan, Knox, Jacob Landry, McCormick, Mena, Newell, Riser, St. Blanc, and Thomas voted yea.

- (2) Add that the Senate president's list of three nominees shall be American Subcontractors Association of La. members.

Representative Deshotel offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 17 yeas and 0 nays. Representatives Deshotel, Carver, Cox, Davis, Domangue, Green, Hebert, Hilferty, Jordan, Knox, Jacob Landry, McCormick, McMakin, Mena, Newell, St. Blanc, and Thomas voted yea.

Representative Deshotel offered a motion to report House Bill No. 623 with amendments. Without objection, House Bill No. 623 was reported with amendments by a vote of 18 yeas and 0 nays.
