# **House Concurrent Resolution No. 14 by Representative Melerine**

Representative Melerine presented House Concurrent Resolution No. 14, which requests that the state Department of Education study the potential effects of alternative school calendar options on student academic achievement.

Representative Owen offered a motion to report House Concurrent Resolution No. 14 favorably. Without objection, House Concurrent Resolution No. 14 was reported favorably by a vote of 11 yeas and 0 nays. Representatives Schlegel, Amedée, Carlson, Carver, Edmonston, Freiberg, Melerine, Owen, St. Blanc, Tarver, and Taylor voted yea.

# **House Bill No. 121 by Representative Crews**

Representative Crews presented House Bill No. 121, which provides relative to the use of certain names and pronouns for students.

Representative Amedée offered amendments to House Bill No. 121 that:

- 1. Added definitions of "female" and "male".
- 2. Removed volunteers from the definition of "employee".
- 3. Expanded the types of relief that individuals aggrieved by an intentional violation of proposed law may seek.
- 4. Added a two-year prescription on civil actions.
- 5. Changed proposed law regarding an employee's use of pronouns from a requirement to use the pronoun that aligns with the student's sex to an exemption from adverse employment action for refusing to address a student with a pronoun that is inconsistent with his sex.

Representative Amedée offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Schlegel, Amedée, Carlson, Carver, Edmonston, Freiberg, Melerine, Owen, St. Blanc, Tarver, and Taylor voted yea.

## House Bill No. 122 by Representative Horton

Representative Brass offered amendments to House Bill No. 122 that applied the provisions of the bill to both charter schools and nonpublic schools that receive public funds. After discussion, Representative Brass withdrew the amendments.
