III. BUSINESS

Senate Bill No. 316 by Senator Miguez

Senator Miguez presented Senate Bill No. 316, which provides relative to charter schools.

Representative Schlegel offered amendments to Senate Bill No. 316 that removed the exception for "turnaround schools" relative to a charter authorizer's proposed law authority to extend contract terms under certain circumstances, and revised terminology. Representative Schlegel offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Schlegel, Amedée, Carlson, Carpenter, Carver, Edmonston, Freiberg, Melerine, Owen, St. Blanc, Tarver, and Taylor voted yea.

Senator Edmonds presented Senate Bill No. 272, which provides relative to the M.J. Foster Promise Award Program.

Representative Schlegel offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Schlegel, Amedée, Brass, Carpenter, Edmonston, Freiberg, Melerine, Tarver, Taylor, and Young voted yea.

Representative Carpenter offered a motion to report House Concurrent Resolution No. 72 with amendments. Senator Wheat presented Senate Bill No. 56, which provides for the administration of medication to students by certain practitioners.

Representative Schlegel offered amendments to Senate Bill No. 56 to apply the expansion of a physician's license location to prescriptions written for the performance of noncomplex health procedures at school. Without objection, the amendments were adopted by a vote of 8 yeas and 0 nays. Representatives Schlegel, Amedée, Brass, Carver, Edmonston, Tarver, Taylor, and Young voted yea.

Jennifer Ricard, no address provided, spoke in support of Senate Bill No. 56.

Representative Taylor offered a motion to report Senate Bill No. 56 with amendments. Without objection, Senate Bill No. 56 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Schlegel, Amedée, Brass, Carver, Edmonston, Melerine, Tarver, Taylor, and Young voted yea.
