III. DISCUSSION OF LEGISLATION

Senate Bill No. 337 by Senator Boudreaux

Senator Boudreaux presented Senate Bill No. 337, which provides for a premium discount for certain military personnel.

Representative Firment offered amendments to:

- (1) Provide an effective date of Jan. 1, 2025; and
- (2) Make technical changes.

Representative Firment offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Firment, Bamburg, Braud, Brown, Freeman, Galle, Hebert, Henry, Mena, and Wilder voted yea.

Senate Bill No. 338 by Senator Boudreaux

Senate Bill No. 58 by Senator Talbot

Senator Barrow presented Senate Bill No. 344, which requires an applicant or an existing insured regarding a homeowner's insurance policy to disclose to their insurer the property is to be used or is being used as a group home.
