## III. DISCUSSION OF LEGISLATION

## House Bill No. 360 by Representative Melerine

Representative Tarver offered a motion to voluntarily defer action on House Bill No. 360, which repeals the Workers' Compensation Advisory Council. Without objection, action on House Bill No. 360 was voluntarily deferred by a vote of 9 yeas and 0 nays. Representatives Crews, Bamburg, Chassion, Dewitt, Echols, Glorioso, Horton, Tarver, and Wilder voted yea.

## House Bill No. 764 by Representative Taylor

Representative Tarver offered a motion to voluntarily defer action on House Bill No. 764, which provides relative to defenses in workers' compensation claims. Without objection, action on House Bill No. 764 was voluntarily deferred by a vote of 9 yeas and 0 nays. Representatives Crews, Bamburg, Chassion, Dewitt, Echols, Glorioso, Horton, Tarver, and Wilder voted yea.

## House Bill No. 765 by Representative Taylor

Representative Tarver offered a motion to voluntarily defer action on House Bill No. 765, which provides relative to a presumption of compensability under workers' compensation. Without objection, action on House Bill No. 765 was voluntarily deferred by a vote of 9 yeas and 0 nays. Representative Echols offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Crews, Bamburg, Chassion, Dewitt, Echols, Glorioso, Horton, Larvadain, McMakin, Melerine, Mena, Phelps, Tarver, Walters, and Wilder voted yea.

- (5) Provide a burden of proof for the party seeking attorney fees; and
- (6) Make technical changes.

# **House Bill No. 712 by Representative Crews**

Representative Crews presented House Bill No. 712, which provides relative to the resignation from labor organizations for teachers and other school employees and the collection of membership dues for political activities.

Representative Echols offered amendments to make technical changes. Representative Echols offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Crews, Bamburg, Chassion, Dewitt, Echols, Glorioso, Horton, Larvadain, Melerine, Tarver, Walters, and Wilder voted yea.

Representative Echols offered amendments:

- (1) To delete provisions of law related to the membership dues for political activities;
- (2) To remove the collective bargaining provision;
- (3) To add R.S. 42457 to include notification requirements from when an employee ceases to withhold union dues; and
- (4) To make technical changes.

Representative Echols offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Crews, Bamburg, Chassion, Dewitt, Echols, Glorioso, Horton, Larvadain, McMakin, Melerine, Tarver, Walters, and Wilder voted yea.
