III. DISCUSSION OF LEGISLATION

House Concurrent Resolution No. 101 by Representative Boyer

Representative Boyer presented House Concurrent Resolution No. 101, which urges and requests the Department of Transportation and Development to seek a waiver for a gateway sign permit for a "Crawfish Expressway" sign in Breaux Bridge.

Representative Boyer offered a motion to report House Concurrent Resolution No. 101 favorably. Without objection, House Concurrent Resolution No. 101 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Schamerhorn, Tarver, Walters, and Wiley voted yea.

House Concurrent Resolution No. 112 by Representative Phelps

On behalf of Representative Phelps, Representative Boyer presented House Concurrent Resolution No. 112, which urges and requests the Department of Transportation and Development to form a highly collaborative approach with political subdivisions regarding the status of projects in local areas.

Representative Boyer offered a motion to report House Concurrent Resolution No. 112 favorably. Without objection, House Concurrent Resolution No. 112 was reported favorably by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Schamerhorn, Tarver, Walters, and Wiley voted yea.

House Bill No. 738 by Representative Bourriaque

Representative Bourriaque presented House Bill No. 738, which re-creates the Department of Transportation and Development.

Representative Bourriaque offered amendments to:

(1) Change the "sunset"date for the Dept. of Transportation and Development to July 1, 2025, instead of July 1, 2029, with the beginning of termination on July 1, 2024.

(2) Make technical changes.

Representative Bourriaque offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Schamerhorn, Tarver, Walters, and Wiley voted yea.

Joe Donahue, DOTD, 1201 Capitol Access Road, Baton Rouge, LA 70802, spoke for information only on House Bill No. 738.

Representative Wiley offered a motion to report House Bill No. 738 with amendments. Without objection, House Bill No. 738 was reported with amendments by a vote of 9 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Schamerhorn, Tarver, Walters, and Wiley voted yea.

Without objection, the motion passed by a vote of 8 yeas and 0 nays. Representatives Bourriaque, Boyer, Braud, Dickerson, Fontenot, Tarver, Walters, and Wiley voted yea.
