**III. INSTRUMENTS TO BE HEARD**

**House Bill No. 718 by Representative Carver**

Representative Carver presented House Bill No. 718, which repeals certain provisions of law referring to inheritance taxes.

Representative Bayham offered a motion to report House Bill No. 718 favorably. Without objection, House Bill No. 718 was reported favorably by a vote of 14 yeas and 0 nays. Representatives Emerson, Brass, Bamburg, Bayham, Billings, Echols, Farnum, Gallé, Henry, McMahan, Myers, Orgeron, Wilder, and Willard voted yea.

**House Bill No. 259 by Representative Beaulieu**

Representative Beaulieu presented House Bill No. 259, which reduces the severance tax rate for oil over a certain period of time and specifies the severance tax rate for oil produced from certain wells.

Representative Jacob Landry, District 49, 106 E Edwards St., Erath, LA 70533, spoke in sponsorship of this measure.

Mr. Mike Mancla, president, Louisiana Oil and Gas Association (LOGA), 1331 Lakeridge Dr., Baton Rouge, LA 70802, spoke in support of House Bill No. 259 and provided a handout, Exhibit A, which is included in the committee record.

Mr. Ben Vincent, Legislative Fiscal Office (LFO), 900 N. Third St., 18th floor, Baton Rouge, LA 70802, spoke for information only on House Bill No. 259.

#### **House Bill No. 418 by Representative Beaulieu**

Representative Beaulieu presented House Bill No. 418, which reduces severance tax rates on oil and gas produced from inactive wells and orphan wells.

Mr. Mike Mancla, president, Louisiana Oil and Gas Association(LOGA), 1331 Lakeridge Dr., Baton Rouge, LA 70802, spoke in support of House Bill No. 418.

Representative Brass offered amendments to change the effective date of proposed law from July 1, 2024, to October 1, 2024.

Mr. Guy Cormier, executive director, Police Jury Association of Louisiana, 707 N. Seventh St., Baton Rouge, LA 70802, spoke in support of House Bill No. 418.

Representative Brass offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Brass, Bamburg, Bayham, Billings, Echols, Farnum, Gallé, Henry, Mandie Landry, McMahan, Myers, Orgeron, Selders, Willard, and Young voted yea.

Representative Echols offered a motion to report House Bill No. 418 with amendments. Without objection, House Bill No. 418 was reported with amendments by a vote of 15 yeas and 0 nays. Representatives Brass, Bamburg, Bayham, Billings, Echols, Farnum, Gallé, Henry, Mandie Landry, McMahan, Myers, Orgeron, Selders, Willard, and Young voted yea.
