**Senate Bill No. 451 by Senator Bouie**

Senator Bouie presented Senate Bill No. 451, which extends the sunset of the Louisiana Tax Free Shopping Program.

Representatives Bamburg, Billings, Echols, Farnum, Gallé, Henry, McMahan, Myers, Orgeron, and Wilder voted nay. Representative Emerson abstained.
