III. INSTRUMENTS TO BE HEARD

House Bill No. 1 by Representative Emerson

Representative Emerson presented House Bill No. 1, which provides for a flat rate for purposes of calculating income tax for individuals, estates, and trusts, increases the standard deduction, and modifies or repeals certain income tax deductions and credits.

Representative Wilder offered a motion to report House Bill No. 1 favorably, to which Representative Willard objected. The administrative assistant called the roll, and House Bill No. 1 was reported favorably by a vote of 15 yeas and 3 nays. Representatives Emerson, Brass, Bamburg, Bayham, Billings, Farnum, Gallé, Henry, LaCombe, McMahan, Myers, Orgeron, Selders, Wilder, and Young voted yea. Representatives Bryant, Mandie Landry, and Willard voted nay.

House Bill No. 3 by Representative Emerson

Representative Emerson presented House Bill No. 3, which repeals the corporation franchise tax and limits eligibility of certain credits to be claimed against corporation franchise tax.

Representative Brass offered amendments which changes the effective from July 1, 2025 to upon signature of the governor.

Representative Brass offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 17 yeas and 0 nays. Representatives Emerson, Brass, Bamburg, Bayham, Billings, Bryant, Farnum, Gallé, Henry, LaCombe, Mandie Landry, McMahan, Myers, Orgeron, Selders, Wilder, and Willard voted yea.

Representative Brass offered a motion to recess. Without objection, the motion passed by a vote of 17 yeas and 0 nays. Representatives Emerson, Brass, Bamburg, Bayham, Billings, Farnum, Gallé, Henry, LaCombe, Mandie Landry, McMahan, Myers, Orgeron, Selders, Wilder, Willard, and Young voted yea.

The committee recessed at 11:47 a.m. The committee reconvened at 1:10 p.m. The committee administrative assistant called the roll.

Representative Bamburg offered a motion to report House Bill No. 3 with amendments, to which Representative Willard objected. The administrative assistant called the roll, and House Bill No. 3 was reported with amendments by a vote of 17 yeas and 1 nays. Representatives Emerson, Brass,

Bamburg, Bayham, Billings, Bryant, Farnum, Gallé, Henry, LaCombe, Mandie Landry, McMahan, Myers, Orgeron, Selders, Wilder, and Young voted yea. Representative Willard voted nay.

House Bill No. 7 by Representative Emerson

Representative Emerson presented House Bill No. 7 a constitutional amendment which revises Article VII of the Constitution of La.

Representative Brass offered amendments which: (1) restrict deposit of mineral revenues into the Budget Stabilization Fund pursuant to proposed constitutional amendment to 15% of remaining mineral revenues after allocations and deposits required by constitution and law have been made; (2) update Coastal Protection and Restoration Fund language in present and proposed constitution to reflect ratification by the voters at the November 5, 2024, election of changes to revenues eligible for deposit into the fund; (3) delete provision requiring a specific legislative instrument adopted by 2/3 of the elected members of each house to change a dedication of interest and investment income from a permanent trust and add provisions requiring passage of a law by 2/3 of the elected members of each house to change any such dedication; (4) add provision requiring restrictions on permanent trusts to apply to subfunds created within a permanent trust; (5) add provision authorizing change to a fund's status as a permanent trust fund by a law enacted by the favorable vote of 2/3 of the elected members of each house of the legislature; (6) delete provisions regarding restrictions on program funds and add the following requirements in lieu thereof: require a law enacted by 2/3 of the elected members of each house to create or designate a fund as a program fund or to change the designation of a fund as a program fund and provide that appropriation of monies from a program fund shall only require a majority vote, unless the terms of the fund require otherwise; (7) add provisions restricting ability of legislature to dedicate tobacco settlement agreement proceeds by law to the Health Excellence Fund within the Millennium Trust; (8) add Wildlife and Fisheries Conservation Fund to the constitution as Art. VII, §23; and (9) make technical and conforming changes.

Representative Brass offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 18 yeas and 0 nays. Representatives Emerson, Brass, Bamburg, Bayham, Billings, Bryant, Farnum, Gallé, Henry, LaCombe, Mandie Landry, McMahan, Myers, Orgeron, Selders, Wilder, Willard, and Young voted yea.
