III. DISCUSSION OF LEGISLATION

House Bill No. 35 by Representative Romero

Representative Romero presented House Bill No. 35, which provides for a minimum mandatory sentence for certain hit and run driving offenses.

Representative Fontenot offered amendments to make technical changes and to add that the driver's vehicle was directly involved in the accident. Representative Fontenot offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

amendment was adopted by a vote of 11 years and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

On behalf of the author, Representative Adams offered amendments to add an additional penalty of five dollars to speeding violations and to add an additional penalty of ten dollars to drag racing violations. Representative Adams offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Representative Villio offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Bruce Reilly, VOTE, 4930 Washington Avenue, New Orleans, LA 70125, spoke in support of House Bill No. 388.

Representative Villio offered a motion to reconsider the vote on the previously adopted amendment. Without objection, the motion was adopted by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Representative Villio offered a motion to withdraw the previously adopted amendment. Without objection, the amendment was withdrawn by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Representative Knox offered an amendment to remove the deadline for certain duties of the Department of Public Safety and Corrections. Representative Knox offered a motion to adopt the amendment. Without objection, the amendment was adopted by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Representative Villio offered amendments to make technical changes and remove a provision of proposed law that provided an additional circumstance of second degree murder for the killing of a human when the offender is in, or has escaped from, the lawful custody of a law enforcement officer or a place of lawful confinement, even though the offender has no intent to kill or inflict great bodily harm. Representative Villio offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, and Walters voted yea.

Representative Villio offered a motion to report House Bill No. 260 with amendments. Without objection, House Bill No. 260 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, and Walters voted yea.

House Bill No. 492 by Representative Ventrella

Representative Ventrella presented House Bill No. 492, which provides relative to cruelty to animals.

On behalf of the author, Representative Boyer offered amendments to add an animal shelter or rescue location as an area where a person may deliver an animal which he found running at large and to clarify that an element of aggravated cruelty to animals is when a person fails to provide proper veterinary care which results in the animal's death. Representative Boyer offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Representative Boyer offered a technical amendment. Representative Boyer offered a motion to adopt the amendment. Without objection, the amendment was adopted by a vote of 12 yeas and 0 nays. Representatives Villio, Adams, Bacala, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.

Charlotte Farshian, Ouachita Parish District Attorney's Office, 400 St. John Street, Monroe, LA 71201, spoke in support of House Bill No. 492.

Representative Knox offered a motion to report House Bill No. 492 with amendments. Without objection, House Bill No. 492 was reported with amendments by a vote of 11 yeas and 0 nays. Representatives Villio, Adams, Boyer, Cox, Fontenot, Horton, Knox, LaFleur, Moore, Walters, and Wiley voted yea.
