**III. DISCUSSION OF LEGISLATION****Senate Bill No. 73 by Senator Reese**

Senator Reese presented Senate Bill No. 73, which provides for sequestration of carbon dioxide (8/1/25).

Representative Jacob Landry offered a motion to invoke the Three-Minute Rule. Without objection, the motion passed by a vote of 14 yeas and 0 nays. Representatives Geymann, Bryant, Carrier, Coates, Dewitt, Domangue, C. Travis Johnson, LaCombe, Jacob Landry, Mack, McCormick, Orgeron, Riser, and Zeringue voted yea.

Tommy Fauchaux, LMOGA, no witness card provided, spoke in opposition to Senate Bill No. 73.

David Cresson, Louisiana Chemical Association, no witness card provided, spoke in opposition to Senate Bill No. 73.

Representative Coates offered a motion to report Senate Bill No. 73 favorably. Without objection, Senate Bill No. 73 was reported favorably by a vote of 14 yeas and 0 nays. **House Bill No. 4 by Representative Owen**

Representatives Bryant, Dewitt, Domangue, C. Travis Johnson, Kerner, LaCombe, Jacob Landry, Orgeron, Riser, and Zeringue voted nay.

**House Bill No. 601 by Representative Geymann**

*Representative Orgeron in the chair.*

Representative Geymann presented House Bill No. 601, which provides relative to carbon dioxide sequestration.

Representative Orgeron offered amendments to:

- (1) Remove 95% consent required for carbon capture and storage (CCS) pipeline expropriation.
- (2) Prohibit expropriation for CCS pipelines.
- (3) Provide that certificates of public convenience and necessity for CCS pipelines are required for construction but do not authorize the use of expropriation.
- (4) Require notice to landowners that CCS pipelines do not have authorization to use expropriation.

Representative Orgeron offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 13 yeas and 0 nays. Representatives Geymann, Carrier, Coates, Dewitt, Domangue, C. Travis Johnson, Kerner, LaCombe, Jacob Landry, Mack, McCormick, Orgeron, and Zeringue voted yea.

Travis Johnson, Kerner, Jacob Landry, Orgeron, Riser, and Zeringue voted nay.

### **House Bill No. 353 by Representative Mack**

Representative Mack presented House Bill No. 353, which provides relative to carbon dioxide sequestration.

Representative Mack offered amendments to:

- (1) Remove requirement that the department make certain findings regarding minerals located below a storage facility.
- (2) Reduce the types of entities that must participate in emergency and remedial response plan training.
- (3) Reduce required testing of emergency alert systems from semi-annually to annually.
- (4) Remove requirement that operators provide fire departments with necessary equipment and supplies.

- (5) Add requirement that equipment and supplies necessary for emergency response be identified in tabletop exercises prior to injection and that those identified as necessary are available to certain fire departments.
- (6) Change financial security requirements to clarify that remediation only applies to contamination caused by an operator's own storage facility.

Representative Mack offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Geymann, Carrier, Coates, Dewitt, Domangue, Jacob Landry, Mack, McCormick, Orgeron, and Riser voted yea.

Representative Dewitt offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 12 yeas and 0 nays. Representatives Geymann, Carrier, Coates, Dewitt, Domangue, C. Travis Johnson, Jacob Landry, Mack, McCormick, Orgeron, Riser, and Zeringue voted yea.

### **House Bill No. 537 by Representative Schamerhorn**

Representative Schamerhorn presented House Bill No. 537, which authorizes liens for victims of CO2 pipeline disasters.

### **House Bill No. 522 by Representative McCormick**

Representative McCormick presented House Bill No. 522, which places a moratorium on carbon dioxide sequestration.

Representative McCormick offered an amendment to limit the moratorium to make it only apply to carbon storage on private property without landowner consent and related actions by the department. Representative McCormick offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 10 yeas and 0 nays. Representatives Geymann, Coates, Dewitt, Domangue, LaCombe, Jacob Landry, McCormick, Orgeron, Riser, and Zeringue voted yea.

### **House Bill No. 380 by Representative Schamerhorn**

Representative Schamerhorn presented House Bill No. 380, which removes eminent domain authority for carbon dioxide sequestration.

Representative Dewitt offered an amendment that originated in committee to remove all portions of the bill that repeal eminent domain authority for carbon sequestration pipelines. Representative Dewitt offered a motion to adopt the proposed amendment. Without objection, the amendment was adopted by a vote of 10 yeas and 0 nays. Representatives Geymann, Bryant, Coates, Dewitt, Domangue, Jacob Landry, Mack, McCormick, Orgeron, and Zeringue voted yea.

Representative McCormick offered an amendment that originated in committee to add language to the bill requiring the consent of all landowners in a carbon sequestration unit. Representative McCormick offered a motion to adopt the proposed amendment, to which Representative Dewitt objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 5 yeas and 6 nays. Representatives Geymann, Bryant, Coates, Mack, and McCormick voted yea. Representatives Dewitt, Domangue, Jacob Landry, Orgeron, Riser, and Zeringue voted nay.

Representative McCormick offered a motion to report House Bill No. 380 with amendments, to which Representative Orgeron objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 5 yeas and 8 nays. Representatives Geymann, Coates, Dewitt, Mack, and McCormick voted yea. Representatives Bryant, Domangue, C. Travis Johnson, LaCombe, Jacob Landry, Orgeron, Riser, and Zeringue voted nay.
