Representative Myers offered a motion to amend statutes that survivors of a member in a state or statewide retirement system shall be entitled to 100% of the member's benefit if the member was killed by an intentional act of violence. Without objection, the motion passed by a vote of 9 yeas and 0 nays. Representatives Bacala, Adams, Berault, Carlson, Carrier, Egan, Kerner, Myers, and Taylor voted yea.

Representative Berault offered a motion that any survivor of public employees killed in an intentional act of violence in the line of duty shall be entitled to \$250,000, subject to appropriation. Without objection, the motion passed by a vote of 9 yeas and 0 nays. Representatives Bacala, Adams, Berault, Carlson, Carrier, Egan, Kerner, Myers, and Taylor voted yea.

Representative Taylor offered a motion that any survivor of a member of a state retirement shall be eligible for 100% of the member's retirement benefit. Without objection, the motion passed by a vote of 9 yeas and 0 nays. Representatives Bacala, Adams, Berault, Carlson, Carrier, Egan, Kerner, Myers, and Taylor voted yea.
