**III. DISCUSSION OF LEGISLATION**

**House Bill No. 101 by Representative Carpenter**

Representative Carpenter presented House Bill No. 101, which provides relative to the civil service status of employees of the East Baton Rouge Parish Housing Authority.

Representative Freiberg offered a motion to report House Bill No. 101 favorably. Without objection, House Bill No. 101 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Huval, Edmonds, Farnum, Freiberg, Gadberry, Green, Kerner, Lyons, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.

**House Bill No. 102 by Representative Glover**

On behalf of Representative Glover, Representative Carpenter presented House Bill No. 102, which provides relative to the civil service status of employees of the Housing Authority of the City of Shreveport.

Representative Stagni offered a motion to report House Bill No. 102 favorably. Without objection, House Bill No. 102 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Huval, Edmonds, Farnum, Freiberg, Gadberry, Green, Kerner, Lyons, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.

Representatives Huval, DuBuisson, Edmonds, Farnum, Freiberg, Gadberry, Green, Kerner, Lyons, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.

#### **House Bill No. 373 by Representative McKnight**

Representative McKnight presented House Bill No. 373, which provides relative to the Westminster Pine Park Crime Prevention and Neighborhood Improvement District in East Baton Rouge Parish.

Representative Freiberg offered a motion to report House Bill No. 373 favorably. Without objection, House Bill No. 373 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Huval, DuBuisson, Edmonds, Farnum, Freiberg, Gadberry, Green, Kerner, Lyons, McKnight, Schamerhorn, Stagni, and Willard voted yea.

#### **House Bill No. 647 by Representative Selders**

Representative Selders presented House Bill No. 647, which authorizes the East Baton Rouge Redevelopment Authority to use a trade name.

Representative Freiberg offered a motion to report House Bill No. 647 favorably. Without objection, House Bill No. 647 was reported favorably by a vote of 13 yeas and 0 nays. Representatives Huval,

DuBuisson, Edmonds, Farnum, Freiberg, Gadberry, Green, Kerner, Lyons, McKnight, Schamerhorn, Stagni, and Willard voted yea.

### **House Bill No. 314 by Representative Schamerhorn**

Representative Farnum offered a motion to report House Bill No. 314 favorably, to which Representative Stagni objected. The administrative assistant called the roll, and the motion failed to pass by a vote of 4 yeas and 11 nays. Representatives Farnum, Green, Schamerhorn, and Willard voted yea. Representatives Huval, DuBuisson, Edmonds, Freiberg, Gadberry, Kerner, Lyons, Marcelle, McKnight, Newell, and Stagni voted nay.

### **House Bill No. 372 by Representative James**

Representative James presented House Bill No. 372, which creates the Forest Oak Windsor Place Crime Prevention, Improvement, and Beautification District in East Baton Rouge Parish.

Representative Freiberg offered a motion to report House Bill No. 372 favorably. Without objection, House Bill No. 372 was reported favorably by a vote of 15 yeas and 0 nays. Representatives Huval, DuBuisson, Edmonds, Farnum, Freiberg, Gadberry, Green, Kerner, Lyons, Marcelle, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.

**House Bill No. 797 by Representative Duplessis**

Representative Duplessis presented House Bill No. 797, which authorizes parishes and municipalities to provide relative to employee leave benefits.

Representative Willard offered amendments that Representative Duplessis explained would make the bill apply to paid sick leave and family and medical leave; the amendments also eliminated references to vacation leave and pay. Representative Willard offered a motion to adopt the proposed amendments. Without objection, the amendments were adopted by a vote of 15 yeas and 0 nays. Representatives Huval, DuBuisson, Edmonds, Farnum, Freiberg, Gadberry, Green, Kerner, Lyons, Marcelle, McKnight, Newell, Schamerhorn, Stagni, and Willard voted yea.

The committee administrative assistant called the roll, and the motion failed to pass by a vote of 6 yeas and 9 nays. Representatives Green, Lyons, Marcelle, Newell, Stagni, and Willard voted yea. Representatives Huval, DuBuisson, Edmonds, Farnum, Freiberg, Gadberry, Kerner, McKnight, and Schamerhorn voted nay.

Witness cards submitted by individuals who did not speak are as follows: 2 in support, and 6 in opposition. Witness cards are included in the committee records.

Statements submitted in accordance with House Rule 14.33 in lieu of appearing before the committee are as follows: 19 in support. Copies of these statements are included in the committee records.

#### **House Bill No. 850 by Representative Ivey**

Representative Ivey presented House Bill No. 850, which provides relative to the creation of and the levy of taxes by certain special districts.

Representative Edmonds offered a motion to report House Bill No. 850 favorably. Without objection, House Bill No. 850 was reported favorably by a vote of 10 yeas and 0 nays. Representatives Huval, DuBuisson, Edmonds, Farnum, Freiberg, Gadberry, Kerner, McKnight, Schamerhorn, and Stagni voted yea.


