STATE OF MAINE

Joint Resolution Memorializing The Congress of The United States To Remove Tobacco Subsidies

We, your Memorialists, the members of the One Hundred and Eighteenth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the President of the United States and the United States Congress, as follows:

WHEREAS, tobacco is addictive and detrimental to people's health; and

WHEREAS, people of all ages are affected by the use of tobacco; and

WHEREAS, the United States Secretary of Agriculture sets price supports for tobacco; authorizes loans to tobacco producers; provides noninsured crop disaster assistance; and, through the Commodity Credit Corporation, provides federal crop insurance for tobacco producers; and

WHEREAS, the State of Maine, the 49 other states and the Federal Government have spent billions of dollars collectively on health care costs related to tobacco; and

WHEREAS, farms with fertile soil grow over a ton of tobacco per acre; and

WHEREAS, 124,000 farms in the United States grow a total of 1.65 billion pounds of tobacco annually; and

WHEREAS, the \$358.5 billion settlement from tobacco companies to the states could be used by producers to grow food crops; and

WHEREAS, the tobacco quota rights program gives producers permission to grow tobacco at \$8 per pound and gives transition payments to producers who lease the quota rights; and

WHEREAS, the price paid to tobacco producers for tobacco will fail if the price support is eliminated; and

WHEREAS, federal price supports are critical and producers will not grow tobacco without this assistance; now, therefore, be it

RESOLVED: That We, your Memorialists, request the President of the United States and the United States Congress to remove the financial assistance necessary to grow the tobacco crop; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to Honorable William J. Clinton, President of the United States; the President of the United States Senate; the Speaker of the House of Representatives of the United States; the Speaker of the House or the equivalent officer in the 49 other states; the President of the Senate or the equivalent officer in the 49 other states; and each member of the Maine Congressional Delegation.

Resolution No. 1

A RESOLUTION MEMORIALIZING CONGRESS TO SUPPORT LEGISLATIVE INITIATIVES TO DISCOURAGE USE OF PUBLIC RESOURCES FOR MOVEMENT OF PROFESSIONAL SPORTS FRANCHISES AND TO REPEAL ANTITRUST EXEMPTIONS FOR PROFESSIONAL SPORTS.

WHEREAS, professional sports can play an important role in the social and cultural atmosphere of a community; and

WHEREAS, various communities seek to have professional sports franchises; and

WHEREAS, the use of public resources to encourage professional sports franchises to relocate from one community to another is a form of counterproductive economic competition that produces overall detriment to all states, while providing potential unjust enrichment to the owners of these franchises; and

WHEREAS, community ownership of professional sports franchises have the potential to maximize the social, cultural, and economic advantages of sports franchises to a community, while minimizing threats of relocation that result in counterproductive economic competition; and

WHEREAS, certain professional sports leagues and associations have adopted policies that prohibit or restrict community ownership of professional sports franchises; and

WHEREAS, federal laws and policies, such as exemption from antitrust laws, contribute to economic inefficiency and to wasteful use of public resources; NOW, THEREFORE,

BE IT RESOLVED by the Legislature of the State of Minnesota that it strongly urges the Minnesota congressional delegation to support legislative efforts in Congress that will:

(1) discourage movement of professional sports franchises, including prohibiting the use of public resources in connection with this movement;

(2) prohibit professional sports leagues from forbidding community ownership of professional sports franchises;

(3) tax benefits that are provided by the public to professional sports franchises; and

(4) repeal antitrust exemptions for professional sports.

BE IT FURTHER RESOLVED by the Legislature of the State of Minnesota that it strongly urges the governors and legislatures in the other states to promulgate this message.

BE IT FURTHER RESOLVED that the Secretary of State of the State of Minnesota is directed to prepare copies of this memorial and transmit them to the President and the Secretary of the United States Senate, the Speaker and the Clerk of the United States House of
