On motion of Rep. LeBlanc, the calling of the roll was dispensed with.

Motion

On motion of Rep. LeBlanc, the Committee took under consideration House Bill No. 1 at this time.

HOUSE BILL NO. 1—
BY REPRESENTATIVE LEBLANC
AN ACT

Making appropriations for the ordinary expenses of the executive branch of state government, pensions, public schools, public roads, public charities, and state institutions and providing with respect to the expenditure of said appropriations.

Read by title.

Suspension of the Rules

On motion of Rep. LeBlanc, House Rule 6.25 was suspended insofar as requiring the Committee, in considering House Bill No. 1, to proceed *seriatim*.

Rep. Arnold sent up floor amendments which were read as follows:

COMMITTEE OF THE WHOLE HOUSE AMENDMENTS

Amendments proposed by Representative Arnold in the Committee of the Whole House to Engrossed House Bill No. 1 by Representative LeBlanc

AMENDMENT NO. 1

On page 12, between lines 13 and 14, insert the following:

"Provided, however, that of the funds appropriated herein to the Administrative Program for the Office of Urban Affairs and Development, the amount which has been allocated for grants in accordance with the guidelines established by the office shall be distributed only to those legislative districts in which the total minority population of the district exceeds 50.1% of the total district population as determined by the 2000 Federal Census and further shall be distributed one-half proportionately to the respective senate districts and one-half proportionately to the respective house districts."

Rep. Arnold moved the adoption of the amendments.

Rep. LeBlanc objected.

By a vote of 33 yeas and 59 nays, the amendments were rejected.

Rep. Arnold sent up floor amendments which were read as follows:

AMENDMENT NO. 1

On page 12, between lines 13 and 14, insert the following:

"Provided, however, that of the funds appropriated herein to the Administrative Program for the Office of Urban Affairs and Development, the amount which has been allocated for grants in accordance with the guidelines established by the office shall be distributed only to those legislative districts which fall within a city with a population of 20,000 or more as determined by the 2000 Federal Census. The amount available for allocation to each city shall be determined by dividing the city population by the total of all city populations with a population in excess of 20,000 and then by multiplying such ratio by the total appropriation. The amount available for allocation to each house legislative district shall be determined by dividing the population of the district within the city by the city population and then multiplying such ratio by the fifty percent of the city allocation. The amount available for allocation to each senate legislative district shall be determined by dividing the population of the district within the city by the city population and then by multiplying such ratio by the fifty percent of the city allocation."

Rep. Arnold moved the adoption of the amendments.

Rep. LeBlanc objected.

By a vote of 35 yeas and 59 nays, the amendments were rejected.

Rep. Crowe sent up floor amendments which were read as follows:

"Provided, however, that the commissioner of administration shall reduce appropriations for the Executive Office from the State General Fund (Direct) and from the Rural Development Fund so that no funding is provided for the Office of Urban Affairs and Development and the Office of Rural Development. Such monies shall be transferred to Schedule 09-306, Department of Health and Hospitals,

Medical Vendor Payments Program, to be used for support of the state Medicaid program."

Rep. Crowe moved the adoption of the amendments.

Rep. LeBlanc objected.

By a vote of 27 yeas and 74 nays, the amendments were rejected.

Rep LeBlanc moved the adoption of Schedule 07 of House Bill No. 1.

Rep. Romero objected.

By a vote of 96 yeas and 1 nay, Schedule 07 was adopted.

"Provided, however, that of the funds appropriated herein to the Personal Health Services Program out of the State General Fund (Direct), the commissioner of administration shall reduce the State General Fund (Direct) allocated for HIV prevention services for condom distribution by \$720,000."

On page 109, after line 51, insert the following:

"Payable out of State General Fund by Interagency Transfers to the Community Mental Health Program for a residential treatment option pilot program for adolescents to begin no later than December 1, 2003	\$ 2,822,432"
