HB 857 FARRAR — ELECTIONS/CAMPAIGNS: Removes certain exemptions from prohibition against knowingly false statements and disclosure requirement and requires "paid for by" disclosure for certain statements relative to a candidate

HB 1306 LANCASTER — PUBLIC OFFICIALS: Prohibits a public official who qualifies for election from using public funds for a public service announcement using his likeness or voice between the close of qualifying and the promulgation of returns
