- B. For the second and subsequent offenses he shall be fined five hundred dollars, or be imprisoned for not less than thirty days, nor more than sixty days, or both. If convicted three times offense, his occupational license shall be suspended for a thirty-day period. For a third offense, his license shall be revoked and he shall not thereafter be permitted to engage in the business of secondhand dealer in the state of Louisiana.
- Any secondhand dealer convicted of selling stolen goods shall have his occupational retail license revoked.
- D. The occupational license tax collector is hereby vested with the authority, upon motion in a court of competent jurisdiction, to rule the noncomplying secondhand dealer to show cause in not less than two nor more than ten days, exclusive of holidays, as to why the noncomplying secondhand dealer's retail occupational license should not be suspended or revoked as prescribed under this Part. This rule may be tried out of term and in chambers and shall be tried with preference and priority. If the rule is made absolute, the order rendered therein shall be considered a judgment in favor of the municipality or parish.

If the owner of the expiring lease fails to submit an application or notice of intent for any year thereafter, any interest to the use of the water bottom shall revert to the state without further notice or action by the secretary.
- D. When the state agency responsible for implementation of the state's coastal restoration plan notifies the secretary, pursuant to R.S. 56:428.1(A)(1), that it anticipates no further impacts to water bottoms described in Subsection A of this Section, the secretary, in his sole discretion, may issue a lease for the previously leased water bottoms. On the date the lease is to be issued, if the water bottom is not located within the impact area of a projected or an operational coastal restoration project, the lease shall be issued as provided in R.S. 56:428. On the date the lease is to be issued, if the water bottom is located within the projected impact area of a coastal restoration project as provided in R.S. 56:428.1, the lease shall be subject to all provisions and conditions of a lease issued under that Section, including but not limited to Subsection C. On the date the lease is to be issued, if the water bottom is located within the impact area of an operational coastal restoration project as provided in R.S. 56:428.2, the lease shall be subject to all provisions and conditions of a lease issued under that Section, including but not limited to submitting to the stipulation provided for in Subsection C and the requirements of Subsection D. When a death or spontaneous fetal death (stillbirth) occurs in this state or when a dead human body is found, the deceased, stillborn child, or dead human body shall not be interred, deposited in a vault or tomb, removed from the state, cremated, or otherwise disposed of until a burial transit permit for burial, removal, or other disposition has been issued by a local registrar. However, the a dead human body shall not be removed from the state cremated or removed from the continental United States until a burial transit permit has been issued and a the death certificate has been completed by the parish coroner or a physician as required in R.S. 40:34(B)(2)(r).

* * *

§54. Prerequisites for permit

A. No A permit shall be issued for burial within the state, for interment in a vault or tomb, for removal from the state, for scientific use, cremation, removal, or other disposition without the necessity of a completed death certificate. However, no permit for the disposition by eremation or removal from the continental United States shall be issued by a local registrar until a certificate of death or stillbirth, has been completed by the parish coroner or a physician as required in R.S. 40:34(B)(2)(r), as far as it can be completed under the circumstances of the case, and has been filed with him, the a local registrar. No permit may be issued unless and until all the regulations of the Department of Health and Hospitals in respect to the issuance of the permit have been complied with. No permit shall be issued which would be contrary to the sanitary laws of the state.

B. The state registrar shall require for cremation submission of a copy of the coroner's permit for cremation as required in R.S. 33:1566."

- **HB 1946 BEARD** RETIREMENT/FIREFIGHTERS: Provides for method of funding the required employer contributions
- **SB 197 BOISSIERE** CLERKS OF COURT RET: Deletes reference to the chairman of the Senate Finance Committee from provisions of law relating to per diem. (gov sig)
- **SB 199 BOISSIERE** CLERKS OF COURT RET: Provides that the chairman of the Senate Retirement Committee serve as an ex-officio member of the board. (gov sig)
