### Senate Instruments on Second Reading Returned from the Legislative Bureau

Rep. Schneider asked for and obtained a suspension of the rules to take up at this time the following Senate Bills and Joint Resolutions on second reading just returned from the Legislative Bureau, with a view of acting on the same:

#### SENATE BILL NO. 792— BY SENATORS DARDENNE AND HOLLIS AN ACT

To enact R.S. 11:441(G), relative to Louisiana State Employees' Retirement System; to provide with respect to eligibility for retirement for new members; to require new members to have ten years of service at age sixty to be eligible for retirement; to provide for an effective date; and to provide for related matters.

Read by title.

Reported with amendments by the Committee on Retirement.

The committee amendments were read as follows:

#### HOUSE COMMITTEE AMENDMENTS

Amendments proposed by House Committee on Retirement to Reengrossed Senate Bill No. 792 by Senators Dardenne and Hollis

##### AMENDMENT NO. 1

On page 1, line 2, after "To" and before "relative" delete "enact R.S. 11:441(G)," and insert the following:

"amend and reenact R.S. 11:403(5), (6), and (10) and 421(D) through (H) and to enact R.S. 11:62(5)(g), 416.2, 421(I), 441.1, 444.1, 446.1, 447.1, and 542.1,"

##### AMENDMENT NO. 2

On page 1, line 3, after "provide" delete the remainder of the line and on line 4, delete "members to have tens years of service at age sixty to be eligible for retirement;" and insert the following:

"for employee contribution rates, definitions, computation of service credit, eligibility for retirement, retirement benefit options, participation in the Deferred Retirement Option Plan, cost-of-living adjustments, and reemployment after retirement;"

##### AMENDMENT NO. 3

On page 1, line 8, after "Section 1." delete the remainder of the line and delete lines 9 through 17 in their entirety and on page 2, delete lines 1 through 4 in their entirety and insert the following:

"R.S. 11:403(5), (6), and (10) and 421(D) through (H) are hereby amended and reenacted and R.S. 11:62(5)(g), 416.2, 421(I), 441.1, 444.1, 446.1, 447.1, and 542.1 are hereby enacted to read as follows:

##### §62. Employee contributions established

Employee contributions to state and statewide public retirement systems shall be as follows:

\* \* \*

##### (5) Louisiana State Employees' Retirement System

\* \* \*

##### (g) All members hired on or after January 1, 2006 - 8.5%

\* \* \*

##### §403. Definitions

The following words and phrases used in this Chapter, unless a different meaning is clearly required by the context, shall have the following meanings:

\* \* \*

(5)(a) "Average compensation" for those employees hired before January 1, 2006, means the average annual earned compensation of a state employee for the thirty-six highest months of successive employment, or for the highest thirty-six successive joined months of employment where interruption of service occurred; however, average compensation for part-time employees who do not use thirty-six months of full-time employment for average compensation purposes shall be based on the base pay the part-time employee would have received had he been employed on a full-time basis.

(b) "Average compensation" for those employees hired on or after January 1, 2006, means the average annual earned compensation of a state employee for the sixty highest months of successive employment, or for the highest sixty successive joined months of employment where interruption of service occurred; however, average compensation for part-time employees who do not use sixty months of full-time employment for average compensation purposes shall be based on the base pay the part-time employee would have received had he been employed on a full-time basis. Notwithstanding R.S. 11:231(A)(1), the computation of such average compensation for these employees shall be in accordance with the following guidelines:

(i) The amount for the first through the twelfth month shall not exceed the actual compensation for the immediately preceding twelve months by more than fifteen percent.

(ii) The amount for the thirteenth through the twenty-fourth month shall not exceed the actual compensation amount for the first through twelfth month by more than fifteen percent.

(iii) The amount for the twenty-fifth through the thirty-sixth month shall not exceed the actual compensation amount for the thirteenth through twenty-fourth month by more than fifteen percent.

(iv) The amount for the thirty-seventh through the forty-eighth month shall not exceed the actual compensation amount for the twenty-fifth through thirty-sixth month by more than fifteen percent.

(v) The amount for the forty-ninth through the sixtieth month shall not exceed the actual compensation amount for the thirty-seventh through forty-eighth month by more than fifteen percent.

(vi) The limitations on the computation of average compensation in this Paragraph shall not apply to any of the twelve-month periods where compensation increased by more than fifteen percent over the previous twelve-month period solely because of an increase in compensation by a uniform system-wide increase adopted by the Department of Civil Service and approved by the governor, or a pay adjustment enacted by the legislature.

(6)(a) "Base pay" for those employees hired before January 1, 2006, means prescribed compensation for a specific position on a full-time basis, but does not include overtime, per diem, differential pay, payment in kind, premium pay, or any other allowance for expense authorized and incurred as an incident to employment, except for supplemental pay for certain members as provided by Article X, Section 10(A)(1) of the Louisiana Constitution of 1974. Employees who work bi-weekly eighty-hour schedules shall have their earned compensation for such regularly scheduled work considered as part of base pay even if some of these hours are defined as overtime for the purpose of the Fair Labor Standards Act.

(b) "Base pay" for those employees hired on or after January 1, 2006, means the salary paid to those employees to include all payments made to the employee through the payroll system applicable to that employee, but shall not apply to reimbursement of expenses.

\* \* \*

(10)(a) "Earned compensation" for those employees hired before January 1, 2006, means the base pay earned by an employee for a given pay period as reported to the system on a monthly basis by the agency which shall include the cash value of any emolument of office in the form of paid compensation in lieu of salary which is subject to federal and state payroll taxes and includes the full amount earned by an employee, overtime, and per diem earned by an employee of the House of Representatives, the Senate, or an agency of the legislature, and expense allowances and per diem paid to members of the legislature, the clerk, or sergeant at arms of the House of Representatives and president and secretary or sergeant at arms of the Senate.

(b) "Earned compensation" for those employees hired on or after January 1, 2006, means the "base pay" as defined in this Section.

\* \* \*

§416.2. Employment of retirees who became system members on or after January 1, 2006

A. Notwithstanding R.S. 11:416 and 416.1, any retiree who was originally hired on or after January 1, 2006, and who becomes engaged in employment after his retirement which otherwise would render him eligible for membership in the system, shall choose one of the following irrevocable options upon reemployment:

(1) The retiree may regain membership by repaying all retirement benefits received from the system, plus interest thereon at the actuarial rate approved by the board of trustees of the system compounded annually from date of receipt until paid. In addition, the

retiree shall pay into the system an amount equal to the employee and employer contributions which would have been paid had the retiree become a member at the beginning of the resumption of covered employment, plus interest thereon at the actuarial rate compounded annually from date of service until paid. Upon such regaining of membership, he shall have restored to his credit all service standing to his credit at the time of retirement and shall receive service credit for all service rendered since becoming so reemployed and thereafter shall be subject to the same conditions as any other member of the system which are not in conflict herewith. This option shall not be available to retirees who selected the Initial Benefit Option.

(2) The retiree may be rehired by an agency for a position eligible for the system if the retiree has been separated from service for at least ninety calendar days from the date of retirement. If the retiree has been retired for at least ninety days the employing agency may rehire the retiree and the retiree may collect his full retirement benefit and salary without a reduction. However if the retiree is rehired within ninety calendar days of his retirement date, the retiree may not receive his retirement benefit and will be ineligible to receive a retirement benefit unless and until the retiree has been separated from employment for ninety consecutive calendar days before being rehired. In either case the employer shall pay to the system the employer contribution, but the employee shall not pay the employee contribution and shall not be entitled to any supplemental retirement benefit from the system. The employing agency shall continue to pay the employer contributions for the rehired retiree until the retiree terminates service.

B. The agency employing the retiree covered by this system shall immediately notify the system of the retiree's date of employment, the option selected for reemployment purposes, the amount of his starting salary, any subsequent changes in salary, the estimated duration of employment, and the date of termination of employment.

C. Should any employer covered by the system employ a retiree and fail to submit the employer contributions for such rehired retiree, the employer shall be liable for the payment of contributions due from the date of reemployment plus compounded interest at the actuarial rate established by the board.

§421. Computation of service

\* \* \*

D. In the computation of service, those employees hired on or after January 1, 2006, shall receive credit based on the actual time worked. The computation of service credit shall be based on hours worked during the year. Two thousand eighty hours, either at work or on approved leave, shall be computed as one year of service credit. For any year during which an employee worked less than this amount, the hours worked shall be divided by two thousand eighty hours and the resulting fraction of a year shall be the earned service credit for that year.

DE. In no case shall credit be allowed for any period of absence without compensation. A member shall not receive more than one year of credit within any fiscal year prior to January 1, 1973, or within any calendar year after January 1, 1973.

EF. Credit between July 1, 1972 and December 31, 1972, will be limited to one-half year total. However, any member who retires between December 31, 1972 and March 31, 1973 shall receive at least three-quarters of a year service for the period July 1, 1972 to March 31, 1973.

FG. A statement of service will be issued to modify or correct membership or prior service, detailing a recapitulation of all service to the close of the last year.

GH. A member may not receive credit for service which is credited in any other retirement system except where there has been a transfer under the reciprocal transfer agreement provided for by this chapter.

HI. In the computation of any retirement allowance, annuity or benefit, any fractional period of service of less than one year shall be taken into account and a proportionate amount of such retirement allowance, annuity or benefit shall be granted for any such fractional period of service.

\* \* \*

§441.1. Eligibility for retirement for those employees hired on or after January 1, 2006

A. Notwithstanding the provisions of R.S. 11:441 for the purposes of eligibility any member shall be eligible for retirement if he has ten years or more of service, at age fifty-five or thereafter.

B. The remaining provisions of R.S. 11:441 shall apply to employees hired on or after January 1, 2006, when applicable.

\* \* \*

§444.1. Computation of retirement benefit for those employees hired on or after January 1, 2006

A. Notwithstanding R.S. 11:444, a member who became employed on or after January 1, 2006, shall receive a maximum retirement allowance equal to the following formula:

<u>Years of Service</u>	<u>Percent Per Year of Service</u>
<u>10</u>	<u>2.0</u>
<u>13</u>	<u>2.1</u>
<u>16</u>	<u>2.2</u>
<u>19</u>	<u>2.3</u>
<u>22</u>	<u>2.4</u>
<u>25 or more</u>	<u>2.5</u>

B. The accrual rates established in Subsection A of the Section shall apply to an active member's entire eligible service credit upon retirement if the active member reaches the applicable age and retires thereafter. The accrual rate for any member who becomes inactive before the age of fifty-five but who has ten or more years of eligible service credit and applies for a benefit after attaining the age of fifty-five shall be two percent.

C. The remaining provisions of R.S. 11:444 shall apply to employees hired on or after January 1, 2006, when applicable.

\* \* \*

§446.1. Retirement options available to employees hired on or after January 1, 2006

A. Upon application for retirement, any member who was hired on or after January 1, 2006, may elect to receive his benefit by selecting one of the following retirement options:

(1) In a retirement allowance payable throughout his life, or

(2) Upon his death one-half of his actuarially reduced retirement allowance shall be continued throughout the life of and be paid to the person he nominates by written designation duly acknowledged and filed with the board of trustees at the time of his retirement. However, if the retiree has a spouse at retirement, that spouse shall be the named beneficiary unless the member presents a prenuptial agreement to the system wherein the spouse agreed to waive any rights in the retiree's pension, or a certified judgment of divorce wherein the spouse has given up his community interest in the retiree's benefit, or the spouse signs a spousal waiver on a form prescribed by the system.

B. The Initial Benefit Option as set forth in R.S. 11:446(A)(5) shall be available to employees who were hired on or after January 1, 2006.

C. The remaining provisions of R.S. 11:446 shall apply to employees hired on or after January 1, 2006, when applicable.

§447.1. Deferred Retirement Option Plan for employees hired on or after January 1, 2006

Employees hired on or after January 1, 2006, shall not be eligible to participate in the Deferred Retirement Option Plan.

\* \* \*

§542.1. Retiree cost-of-living adjustment for employees hired on or after January 1, 2006

A. Notwithstanding the provisions of R.S. 11:542, any employee hired on or after January 1, 2006, is entitled to a cost-of-living adjustment if the retiree has been retired at least five years on the date the adjustment is given in an amount not to exceed the lesser of three percent or the increase in the consumer price index, U.S. city average for all urban consumers (CPI-U), as prepared by the U.S. Department of Labor, Bureau of Labor Statistics, for the calendar year immediately preceding the cost-of-living increase payable annually on July first of every year. The percentage of each recipient's cost-of-living increase shall be based on the benefit being paid to the recipient on the effective date of the increase.

B. The cost-of-living increase shall be paid to disability retirees, survivors, and beneficiaries of employees hired on or after January 1, 2006, in accordance with the formula and date set forth in this Section whenever the disability retiree, survivor, or beneficiary has been collecting the benefit for a minimum of five years on the date the adjustment is granted.

Section 3. This Act shall become effective December 31, 2005."

For each fiscal year beginning after June 30, 2003, such payments shall be computed as a level dollar amount over a period of thirty years."

To urge and request the public postsecondary education management boards to use the authority granted each of them by R.S. 17:3351(A)(5)(b)(i) and establish, by not later than the Fall semester of the 2005-2006 academic year, tuition and mandatory attendance fee amounts applicable to nonresident students at institutions under their respective supervision and management that at least equal the average amount of annual tuition and mandatory attendance fees for the ensuing fiscal year applicable

to nonresident students at institutions in states comprising the Southern Regional Education Board, excluding Louisiana, which are in the same category as established by the Southern Regional Education Board.
