**HOUSE BILL NO. 1—
BY REPRESENTATIVE FANNIN
AN ACT**

Making appropriations for the ordinary expenses of the executive branch of state government, pensions, public schools, public roads, public charities, and state institutions and providing with respect to the expenditure of said appropriations.

Called from the calendar.

Read by title.

Rep. Henry sent up floor amendments which were read as follows:

HOUSE FLOOR AMENDMENTS

Amendments proposed by Representatives Geymann and Henry to Engrossed House Bill No. 1 by Representative Fannin

AMENDMENT NO. 1

On page 12, between lines 14 and 15, insert the following:

"F. In order to eliminate the one-time money contained in this Act, including the recommendations for the use of one-time money as proposed in the Executive Budget, and identified by the Legislative Fiscal Officer in the report pursuant to House Rule 7.19, the commissioner of administration is hereby authorized and directed

to reduce the State General Fund (Direct) appropriations contained in this Act by taking such actions as is necessary, including but not limited to, the following:

- (1) Reducing proposed enhancements (\$16,128,267).
- (2) Reducing funding for vacant positions (\$44,241,500).
- (3) Reducing out-of-state and conference travel, supplies, acquisitions (\$41,616,055).
- (4) Reducing professional, personal, and consulting service contracts (\$75,000,000).
- (5) Furlough of employees for two calendar days, as presented by appointing authorities and approved by the Department of Civil Service (\$16,000,000).
- (6) Reducing employee overtime pay (\$19,750,000).
- (7) Incorporating appropriations out of the state general fund out of statutory dedications as provided for in Subsection G of this Section (\$70,751,629).
- (8) Withholding payment of judgments contained in this Act (\$12,000,000).
- (9) Five percent reduction to personnel costs for those employees who rank in the top fifty percent of salaries within the organizational unit in which the reductions will be made with priority given to those who are eligible for retirement, if such retirement benefits will yield ninety percent of their current salary, or if they have less than five people that report directly to them (\$55,000,000).

The commissioner of administration is further authorized and directed to eliminate the one-time money contained in the State General Fund (Direct) identified by the Legislative Fiscal Officer in the report pursuant to House Rule 7.19, and such reduction to State General Fund (Direct) may be achieved through the reductions provided for herein, and is further authorized to adjust the means of financing by eliminating the one-time money contained in the State General Fund by Statutory Dedications out of the Overcollections Fund, the Louisiana Medical Assistance Trust Fund, the TOPS Fund, and the Mega-Project Development Fund and by replacing such adjustments partially or totally with State General Fund (Direct) to effectuate a total savings of \$267,670,431. The commissioner shall make reductions and means of financing adjustments to cause no impact to critical services.

G. Provided, however, that notwithstanding any provision of law to the contrary, the commissioner of administration is hereby authorized and directed to reduce the program expenditures and to adjust the means of financing for the budget units contained in this Act by reducing the appropriation out of state general fund by statutory dedications out of each fund by 10% of the appropriation from such fund contained in the Original version of this Act, and incorporated in the statutory dedication calculation in the official forecast as non-recurring revenues, to effectuate a total reduction of \$139,529,827.

Provided further, however, that the appropriations out of the following funds shall not be reduced: Conservation Fund, Education Excellence Fund, Health Excellence Fund, IEB Statutory Dedication Louisiana Fund, Louisiana Lottery Proceeds Fund, Louisiana Quality Education Support Fund, Transportation Trust Fund, Transportation Trust Fund-Regular, Transportation Trust Fund-Federal, Louisiana Medical Assistance Trust Fund, TOPS Fund, and Medicaid Trust Fund for the Elderly, the Support Education in Louisiana First Fund, and the Compulsive and Problem Gaming Fund.

The state treasurer is hereby authorized and directed to transfer the amount of the reduction of the appropriation out of each fund into the state general fund, \$70,751,629, be it more or less estimated.

H. The legislature hereby recognizes its intention, as represented by its presiding officers, to reduce its expenditures out of the State General Fund (Direct) during Fiscal Year 2012-2013 by \$6,926,393."

Point of Order

Rep. Geymann raised a point of order as to whether House Rule 7.19(D)(2)(a) requires a ruling from the Chair as to whether the above floor amendment appropriates one-time money.

Ruling of the Chair

The Chair ruled that the above floor amendment does not appropriate money and requires no ruling as to whether it may appropriate one-time money.

On motion of Rep. Henry, the amendments were withdrawn.

Rep. Henry sent up floor amendments which were read as follows:

HOUSE FLOOR AMENDMENTS

Amendments proposed by Representatives Geymann and Henry to Engrossed House Bill No. 1 by Representative Fannin

AMENDMENT NO. 1

On page 12, between lines 14 and 15, insert the following:

"F. In order to eliminate the one-time money contained in this Act, including the recommendations for the use of one-time money as proposed in the Executive Budget, and identified by the Legislative Fiscal Officer in the report pursuant to House Rule 7.19, the commissioner of administration is hereby authorized and directed to reduce the State General Fund (Direct) appropriations contained in this Act by taking such actions as is necessary, including but not limited to, the following:

- (1) Reducing proposed enhancements (\$16,128,267).
- (2) Reducing funding for vacant positions (\$44,241,500).
- (3) Reducing out-of-state and conference travel, supplies, acquisitions (\$41,616,055).
- (4) Reducing professional, personal, and consulting service contracts (\$75,000,000).
- (5) Furlough of employees for two calendar days, as presented by appointing authorities and approved by the Department of Civil Service (\$16,000,000).

The commissioner of administration is further authorized and directed to eliminate the one-time money contained in the State General Fund (Direct) identified by the Legislative Fiscal Officer in the report pursuant to House Rule 7.19, and such reduction to State General Fund (Direct) may be achieved through the reductions provided for herein, and is further authorized to adjust the means of financing by eliminating the one-time money contained in the State General Fund by Statutory Dedications out of the Overcollections Fund, the Louisiana Medical Assistance Trust Fund, the TOPS Fund, and the Mega-Project Development Fund and by replacing such adjustments partially or totally with State General Fund (Direct) to effectuate a total savings of \$267,670,431. The commissioner shall make reductions and means of financing adjustments to cause no impact to critical services.

G. Provided, however, that notwithstanding any provision of law to the contrary, the commissioner of administration is hereby authorized and directed to reduce the program expenditures and to adjust the means of financing for the budget units contained in this Act by reducing the appropriation out of state general fund by statutory dedications out of each fund by 10% of the appropriation from such fund contained in the Original version of this Act, and incorporated in the statutory dedication calculation in the official forecast as recurring revenues, to effectuate a total reduction of \$70,751,629.

Provided further, however, that the appropriations out of the following funds shall not be reduced: Conservation Fund, Education Excellence Fund, Health Excellence Fund, IEB Statutory Dedication Louisiana Fund, Louisiana Lottery Proceeds Fund, Louisiana Quality Education Support Fund, Transportation Trust Fund, Transportation Trust Fund-Regular, Transportation Trust Fund-Federal, Louisiana Medical Assistance Trust Fund, TOPS Fund, and Medicaid Trust Fund for the Elderly, the Support Education in Louisiana First Fund, and the Compulsive and Problem Gaming Fund.

The state treasurer is hereby authorized and directed to transfer the amount of the reduction of the appropriation out of each fund into the state general fund, \$70,751,629, be it more or less estimated.

H. The legislature hereby recognizes its intention, as represented by its presiding officers, to reduce its expenditures out of the State General Fund (Direct) during Fiscal Year 2012-2013 by \$6,926,393."
