(C)(1) The purpose of the task force shall be to study and establish the methods and procedures to effectuate the consolidation of the New Orleans Traffic Court and the New Orleans Municipal Court, and to specifically consider in its study, the operation of the courts, their governance, administration, information technology, legal authority, subject matter jurisdiction, process and operation, economies of scale and greater efficiencies, protection of rights and access to justice and procedural fairness.

(2) The task force shall work in conjunction with the Judicial Council of the Supreme Court and the National Center for State Courts.

(D) Members of the task force shall serve without compensation or per diem.

(E) The task force shall submit a report of its findings and recommendations to the speaker of the House and the president of the Senate, no later than thirty days prior to the start of the 2015 Regular Session of the Louisiana Legislature."

Monies in the fund shall be appropriated to the Board of Regents to be allocated to postsecondary education institutions in order to better align each institution with the minimum postsecondary education funding formula implementation rate. Monies in the fund shall be used to calculate a minimum implementation rate of the postsecondary education funding formula. The Board of Regents shall annually establish an allocation of the monies in the fund based on a comparison of the postsecondary education funding formula appropriation of each institution in the current fiscal year with the projected postsecondary education funding formula cost for that institution in the next fiscal year. Monies in the fund shall be allocated to the institutions with the lowest implementation rates to bring the institutions closer to the minimum implementation rate.

§3138.3. Science, Technology, Engineering, and Math (STEM) Upgrade Fund

A. There is hereby established as a special fund in the state treasury the Science, Technology, Engineering, and Math (STEM) Upgrade Fund, hereafter referred to as "the fund". Subject to appropriation of monies into the fund by the legislature, the state treasurer is directed to deposit into the fund at the beginning of each fiscal year an amount equal to at least five percent of the amount of monies deposited into the Workforce and Innovation for a Stronger Economy Fund. Monies in the fund shall be invested in the same manner as monies in the state general fund. Interest earned on investment of monies in the fund shall be credited to the fund. Unexpended and unencumbered monies in the fund at the end of the fiscal year shall remain in the fund.

B. Monies in the fund shall be appropriated to the Board of Regents and allocated as follows:

(1) One million dollars for STEM upgrades at Southern University and Agricultural and Mechanical College.

(2) One million dollars for STEM upgrades at Grambling State University."
