Motion

Suspension of the Rules

Rep. Henry moved to suspend Rule 6.25 to consider House Bill No. 105 schedule by schedule, which motion was agreed to.

AN ACT

Making annual appropriations for Fiscal Year 2019-2020 for the ordinary expenses of the executive branch of state government, pensions, public schools, public roads, public charities, and state institutions and providing with respect to the expenditure of said appropriations.

Read by title.

Rep. Leger sent up committee amendments which were read as follows:

On page 1, at the beginning of line 2, delete "Making" and insert "To make"

AMENDMENT NO. 2

On page 12, line 17, after "(Direct)," and before "and shall" and insert "whenever possible,"

AMENDMENT NO. 3

On page 71, delete lines 30 through 38 in their entirety.

AMENDMENT NO. 4

On page 77, delete lines 22 through 24 in their entirety.

AMENDMENT NO. 5

On page 79, delete lines 6 through 9 in their entirety.

AMENDMENT NO. 6

On page 92, delete lines 1 through 3 in their entirety.

Rep. Leger moved the adoption of the amendments.

Rep. Henry objected.

By a vote of 35 yeas and 57 nays, the amendments were rejected.

AMENDMENT NO. 1

On page 81, between lines 13 and 14 insert the following:

"The commissioner of administration is hereby authorized and directed to adjust the means of financing for the Payments to Private Providers Program by reducing out of the State General Fund (Direct) by \$2,313,930."

AMENDMENT NO. 2

On page 133, between lines 26 and 27, insert the following:

"Payable out of the State General Fund (Direct) to the Administrative Support Program for operating expenses	\$ 1,772,933

Payable out of the State General Fund (Direct) to the District Support Program for operating expenses	\$ 540,997"
