HOUSE BILL NO. 23— BY REPRESENTATIVE DWIGHT

A JOINT RESOLUTION

Proposing to add Article VII, Section 21(O) of the Constitution of Louisiana, relative to payments in lieu of taxes; to provide for certain agreements authorizing payments in lieu of ad valorem taxes; to provide for agreements authorizing payments in lieu of ad valorem taxes that may allow for property tax exemptions; to provide for certain conditions and limitations; to provide for submission of the proposed amendment to the electors; and to provide for related matters.

BY REPRESENTATIVE JAMES \widetilde{AN} ACT

To amend and reenact Section 8 of the Act that originated as Senate Bill No. 418 of the 2020 Regular Session of the Legislature of Louisiana, relative to the reduction of automobile insurance rates; to provide for the authority of the commissioner of insurance to relieve an insurer from reducing insurance premium rates; to require legislative approval of any relief from reducing insurance premium rates; and to provide for related matters.

BY REPRESENTATIVE ZERINGUE AN ACT

To amend and reenact R.S. 17:3351.20(A)(1) and (F), relative to fees charged to students at public postsecondary education institutions; to extend the authority of a public postsecondary education management board to establish, adjust, and increase certain fees; to provide limitations; to extend the requirement that such boards report annually to the legislature relative to such fees; and to provide for related matters.

AN ACT To amend and reenact R.S. 37:2553(D) and 2558(A), to enact R.S. 37:2551.1, and to repeal R.S. 37:2551.1, relative to the board of examiners of certified shorthand reporters; to create the Board of Examiners of Certified Shorthand Reporters Fund; to provide relative to the disbursement of funds; to provide relative to fees collected from applicants; and to provide for related matters.

AN ACT

To amend and reenact R.S. 33:9021(8) and (10) and 9022(1) and to enact R.S. 33:2760, relative to payments in lieu of taxes; to provide for agreements for investments in political subdivisions authorizing payments in lieu of ad valorem taxes; to provide for agreements authorizing payments in lieu of ad valorem taxes that may allow for property tax exemptions; to provide for the authority of political subdivisions; to provide for ownership and title of property subject to certain agreements; to provide for definitions; to provide for certain conditions and limitations; and to provide for related matters.

HOUSE BILL NO. 3-BY REPRESENTATIVE BISHOP

AN ACT To enact the Omnibus Bond Authorization Act of 2020, relative to the implementation of a five-year capital improvement program; to provide for the repeal of certain prior bond authorizations; to provide for new bond authorizations; to provide for authorization and sale of such bonds by the State Bond Commission; and to provide for related matters.

Read by title.

AMENDMENT NO. 1

On page 7, between lines 26 and 27, insert the following:

"Section 8. Notwithstanding the provisions of R.S. 39:122, for Fiscal Year 2020-2021, the commissioner of administration shall make recommendations to the House Committee on Ways and Means and the Senate Committee on Revenue and Fiscal Affairs concerning the state and nonstate entity projects to be granted lines of credit. The commissioner of administration shall submit to the House Committee on Ways and Means and the Senate Committee on Revenue and Fiscal Affairs a list of state and nonstate entity projects that the division of administration recommends for lines of credit no less than thirty days prior to the meeting date of the State Bond Commission in which the lines of credit are to be considered. The House Committee on Ways and Means and the Senate Committee on Revenue and Fiscal Affairs shall receive the list of recommendations from the division of administration and shall have discretion to either approve the list or make changes to the list. The committees shall make final recommendations and shall separately approve a list of projects which shall be submitted to the State Bond Commission for consideration of lines of credit. Only projects which received approval from both the House Committee on Ways and Means and the Senate Committee on Revenue and Fiscal Affairs shall be submitted to the State Bond Commission for consideration of lines of credit."
