HB 417 may conflict with HB 369 to the extent that HB 369 amends §4(A), relative to income tax.

HB 370 Ivey TAX/AD VALOREM-EXEMPTION: (Constitutional Amendment) Establishes certain property tax exemptions for capital investment projects

HB 417 may conflict with HB 370 to the extent that HB 370 enacts §21(O), relative to ad valorem property tax exemptions.

HB 371 Ivey TAX/AD VALOREM-MFG/EXEMP: (Constitutional Amendment) Authorizes local taxing authorities to enter into cooperative endeavor agreements for the purpose of authorizing payments in lieu of taxes

HB 417 may conflict with HB 371 to the extent that HB 371 enacts §21(O), relative to ad valorem property tax exemptions.

HB 441 Landry TAX/INCOME TAX: (Constitutional Amendment) Provides for the rates and brackets for purposes of calculating individual income tax and the deduction for federal income taxes paid when calculating income tax liability

HB 417 may conflict with HB 441 to the extent that HB 441 amends §4(A), relative to income tax.

HB 486 Devillier TAX/SALES-USE-EXEMPT: (Constitutional Amendment) Provides relative to state sales and use tax exemptions for food for home consumption, utilities for residential use, and prescription drugs

HB 417 may conflict with HB 486 to the extent that HB 486 repeals §2.2, relative to state sales and use tax exemptions for food for home consumption, certain utilities for residential use, and prescription drugs.

HB 487 Echols BUDGETARY CONTROLS: (Constitutional Amendment) Provides relative to deficit avoidance procedures

HB 417 may conflict with HB 487 to the extent that HB 487 amends §10(F), relative to deficit avoidance.



HB 488 Pressly TAX/INCOME TAX: (Constitutional Amendment) Establishes the maximum rate for purposes of calculating individual income taxes and repeals the mandatory deduction for federal income taxes paid

*HB 417 may conflict with HB 488 to the extent that HB 488 amends §4(A), relative to income tax.*

HB 489 Pressly TAX/AD VALOREM-EXEMPTION: (Constitutional Amendment) Exempts items constituting business inventory from ad valorem property tax

*HB 417 may conflict with HB 489 to the extent that HB 489 enacts §21(O), relative to ad valorem property tax exemptions.*

HB 504 Wright TAX/SALES-USE-EXEMPT: (Constitutional Amendment) Provides relative to sales and use tax exemptions for gasoline, diesel fuels, special fuels, food for home consumption, certain residential utilities, and prescription drugs

*HB 417 may conflict with HB 504 in that HB 504 amends §27(A), relative to the transportation trust fund, and repeals §2.2, relative to state tax exemptions for food for home consumption, certain residential utilities, and prescription drugs.*

HB 526 Nelson TAX: (Constitutional Amendment) Provides for state and local revenue

*HB 417 may conflict with HB 526 in that HB 526 amends §4(A), §11(C), §18(C), §18F(1), §20(A)(1), §21(B), §21(F), and §26(B).*

SB 40 Ward TAX/SALES: Constitutional amendment to authorize a parish governing authority to levy sales tax on motor fuels with the approval of the parish electors. (2/3 - CA13s1(A))

*HB 417 may conflict with SB 40 in that SB 40 amends §4(C), relative to income tax, and §27(A), relative to the transportation trust fund..*

SB 154 Smith TAX/AD VALOREM: Constitutional amendment to provide for the adjustment of ad valorem millages. (2/3 - CA13s1(A))

*HB 417 may conflict with SB 154 in that SB 154 amends §23(C), relative to ad valorem property tax millage rate adjustments.*

SB 158 Allain Constitutional amendment to phase out the ad valorem tax on inventory, reduce the maximum amount of the industrial property tax exemption, and provide for funding for local government. (2/3 - CA13s1(A))

*HB 417 may conflict with SB 158 in that SB 154 amends §21(F) and enacts §(O), relative to ad valorem property tax exemptions.*

SB 159 Allain TAX/TAXATION: Constitutional amendment to reduce the maximum rate of individual income tax and to provide for a federal income tax deduction as provided by law. (2/3 - CA13s1(A))

*HB 417 may conflict with SB 159 in that SB 159 amends §4(A), relative to income tax.*
