If the applicant has a complaint, allegation, or investigation pending, the teaching licensing board shall not issue or deny a teaching license to the applicant until the complaint, allegation, or investigation is resolved, or the applicant otherwise satisfies the criteria for licensure in this state to the satisfaction of the teaching licensing board.

 - (b) Determination of teaching.
- (c) Determination of the similarity of the scope of practice of the teaching license issued.
