SB 415 PRICE SHERIFFS PEN/RELIEF FUND Provides for reemployment of retirees of the Louisiana Sheriffs' Pension and Relief Fund. (gov sig)

SB 478 BOUDREAUX LOCAL RETIREMENT Provides for Lafayette Consolidated Government Employees. (8/1/24)
