On page 115, delete lines 28 and 29 and insert the following:

"for the Saskatchewan Legacy and Delta Manitoba Habitat agreements

200,000"

### AMENDMENT NO. 2

On page 115, line 33, after "Program" delete the remainder of the line and delete line 34 and insert the following:

"for wood duck nesting ecology and recruitment in Louisiana

500,000"
